I want to review the new recertification by infection prevention units IPUs). It is essential to point out that this recertification with the process, unlike license renews, can not be completed by regular continuing education alone. 

#### LAPSED DEADLINE/AUDITING

- ✓ If a candidate fails to submit a portfolio by October 31<sup>st</sup>, he or she must take the **online** recertification examination. This Exam must be purchased by November 30<sup>th</sup> and completed by December 31<sup>st</sup>.
- ✓ If a candidate's portfolio is selected for a random audit and the units are not accepted during audit review, the candidate has the opportunity to resubmit their portfolio.
- ✓ If the portfolio is still not accepted after portfolio resubmission, the candidate must take the **proctored recertification examination**, which must be completed by December 31<sup>st</sup>.
