AWARD DESCRIPTION

The **CRE Leadership Excellence Award** recognizes a corporation's Canadian real estate department that has best demonstrated leadership and innovation throughout its real estate portfolio.

Award Criteria and weighting:

- Ability to conform real estate goals and objectives to company's dynamic business drivers and goals / **25%**
- Leadership skills of the real estate department and the ability to lead, motivate and manage real estate teams / **40%**
- Examples of promoting the practice of corporate real estate / **20%**
- Demonstration of individual and team integrity and ethical behaviour / **15%**

SUBMISSIONS OVERVIEW

On page 3 of this fillable PDF, please provide contact information for the Nominee and you, the Nominator. Furthermore, prepare and attach a typewritten description of the project in the **style of a case study**:

- Assessing a need or situation
- Emphasizing new concepts or practices that provide solutions to a need or situation
- Offering performance metrics to validate impact or results, and sharing lessons learned
- Specifying the Nominee's (main contact person's) contribution to project

The description may not exceed five typewritten pages, minimum 10-pt font, double spaced on 8-1/2" x 11" white paper.

Combine PAGE 3 of this Nomination Form with your multi-page description into a **single PDF document**. Plus you may provide up to three digital photographs or renderings of the project, which support your written description. Please ensure the file name for each photo or image clearly corresponds to your submission. This is all the documentation required -- no other project-based items are to be included.

WHO IS ELIGIBLE

Award nominations and submissions are open to both members and non-members of CoreNet Global Canadian Chapter, regardless of the size or location of any nominee. Nominations and submissions are accepted in more than one category, **with the option to self nominate**.

The winner's name will be announced at the REmmy Awards Gala, November 26, 2015, plus the winner's name and corporate logo may be published on the CoreNet Global Canadian Chapter website and in other media announcements.

Where a REmmy nomination is made by a third party, the Nominator submits that the Nominee has agreed to abide by the terms and conditions outlined in this nomination form and **written approval from the Nominee must be included in the submission PDF**.
