# WEBSITE/ENEWLETTER ADVERTISING AGREEMENT

This Advertising Agreement (the "Agreement") is made this \_\_\_\_ day of \_\_\_\_\_, 20\_\_, between the Wausau Chapter, and \_\_\_\_\_ ("Advertiser").

Advertiser desires to advertise on the Wausau Chapter website on a non-exclusive basis at a cost of \$50.00. The Advertiser name, logo and/or link will be placed on the Wausau Chapter website and enewsletters during the term of this agreement.

The parties agree as follows:

1. Term. The term of this Agreement will commence on the date and year first set forth above and will continue for 12 months (the "Term").

2. Use of Names. Advertiser hereby grants Wausau Chapter a limited, revocable, non-exclusive license to use Advertiser's name and logo (the "Advertiser Marks") solely to identify company/organization as an Advertiser of the Wausau Chapter website and e-newsletter. Wausau Chapter agrees not to revise or alter the marks of the Advertiser and not to use the marks in any manner that: diminishes their value or otherwise dilutes them; discredits the owner or tarnishes its reputation or goodwill; is false, misleading or likely to cause confusion, mistake or deception; violates the rights of others; violates any federal, state or local law, regulation or other public policy; or mischaracterizes the relationship between the parties, including, but not limited to the fact that Advertiser is a separate and distinct legal entity from, and is not an agent of or endorsed by the Wausau Chapter or IAAP.

3. Payment. In consideration for the right to advertise with the Wausau Chapter, Advertiser agrees to make a payment to the Wausau Chapter. The payment described in this Section 3 shall constitute payment by Advertiser solely for Advertiser's right to advertise on the Wausau Chapter website and e-newsletter. Such payment shall in no manner be considered compensation or reimbursement for services rendered, activities undertaken by IAAP on behalf of the Advertiser, or income from a partnership or joint venture.

4. Relationship of Parties. The relationship of the parties to each other is that of independent contractors. Nothing herein shall create any association, joint venture, partnership, or agency relationship of any kind between the parties. Neither party is authorized to incur any liability, obligation or expense on behalf of the other, to use the other's monetary credit in conducting any activities under this Agreement, or to represent that the Wausau Chapter is in the business of providing the products and/or services provided by the Advertiser.

5. Indemnification. Advertiser hereby agrees to indemnify, defend and hold harmless the Wausau Chapter and its members and officers from and against any and all claims, actions, demands, losses, damages, judgments, settlements, costs and expenses (including reasonable attorneys' fees and expenses), and liabilities which may arise by reason of any act or omission the Advertiser or any of its employees, or agents; any use of Advertiser's name, logo, website or other information, materials, products or services provided by Advertiser; and/or the inaccuracy or breach of any of the covenants, representations and warranties made by Advertiser in this Agreement. The provisions of this Section 5 shall survive any termination or expiration of this Agreement.
