

China IMA Case Team Champions Visits DFW

On November 6 – 8 (Monday – Wednesday), Chapter Member Jimmie Smith had the opportunity to host a delegation from China – Professor Mike Pu (IMA Global Board Member, Associate Professor at the University of International Business and Economics in Beijing), 4 students (the 5th member of the team was not able to come) from Jiangxi University of Finance and Economics who won the 2017 IMA China Management Accounting Case Competition, and 2 others, plus Judy Bartee (IMA International Coordinator). On Monday evening, they had a traditional Chinese



dinner in DFW Chinatown (Richardson). On Tuesday and Wednesday, they visited 3 local universities (Texas Woman's University, University of North Texas, and The University of Texas at Dallas) to tour their campuses and to meet with their accounting and finance faculty and students. In addition, on Wednesday the group visited the Federal Reserve Bank of Dallas to take their Economy in Action tour. On Wednesday evening, they attended the IMA Dallas Fort Worth Area Chapter Dinner Meeting. At the meeting, Mike Pu gave a presentation on the China Economy – A Chinese Perspective and Ginger White (IMA Global Chair Elect) gave a presentation on Six Sigma at Cummins.

The delegation stopped in Dallas en route to the IMA Student Leadership in Houston (November 9-11), as did IMA Chair Elect Ginger White. The conference drew approximately 600 mostly US accounting and finance students and academics, including almost 100 from Texas colleges and universities. On Saturday evening, after the conference, the entire delegation, Jimmie Smith, plus a number of others from the conference, attended the NBA game between the Houston Rockets and the Memphis Grizzlies.

FRAUD HOTLINE

Be More Cyber-Secure

It's been awhile since I have written a Fraud Hotline article on this extremely important topic which continues to make our lives miserable and is becoming more, not less, pervasive in our society. I found an excellent article in the Spirit magazine published by The Texas A&M Foundation Magazine in the summer of 2017 written by Mr. Daniel Ragsdale, Director of the Texas A&M Cybersecurity Center and professor of practice in computer science and engineering; he explains how you, personally, can protect yourself in an age of increased hacking and identity theft. The following comments are entirely his, unless I specifically comment or use a parenthetical comment.

As more people have smart devices in their homes, on their wrists and in their pockets, our vulnerability to cyberat-tacks multiplies. At the same time, large-scale criminal networks with sophisticated technology are on the rise in Eastern Europe and Southeast Asia. It seems every day that stories about individuals, corporations and governments being hacked grace the front pages (reference the very recent attack on Uber where over 50 million individuals had important and very personal data compromised).

Criminals go where the money is easiest, but that's good news for individuals willing to do a few simple things to improve their personal cybersecurity. With a little effort, you can make yourself a less attractive target.

Accept Inconvenience -

Look for services that offer two-factor authenticity: the requirement that to log into your password-protected content from one device, you must complete a step through another device, such as enter a code delivered via text.

Keep Your Devices Locked – Especially

Your Phone – Make sure your phone screen has a passcode or swipe pattern so that if you accidentally misplace it, you don't lose your identity along with your device. (The secret here is turnoff your cell phone when not in use.)

Use a Password Manager – It is now beyond human capacity to remember all the passwords we need to be secure, says Ragsdale, noting that some individuals have up to 100 password-protected accounts, which leads to poor practices such as reusing passwords and not changing them often enough. The solution? Pay for a password manager. Most services cost between \$3 and \$40 per year and generate secure passwords for unlimited accounts. To access your password list, you'll have to jump through a few hoops....like twofactor authentications....but it beats the alternative: a homemade Excel spreadsheet.

Beware of "Smart" Technology In Your Home – To limit your susceptibility to cyberattack, change all of the automatically-generated passwords associated with your home's technology. This includes appliances with voice activation, webcams, and programs that control your home's heating and cooling systems.

Use Modern Software and Update It Regularly

 Tech companies stop creating updates for your software as it ages, making it more vulnerable, Ragsdale says. Similarly, for any piece of software you own, don't neglect installing automatic updates.....most are security patches.

Watch Out For Spear Phishing - More than 269 billion emails are sent world wide daily; the average office worker can receive as many as 121 in a 24 -hour period. As email volume increases, so do spear phishing attempts, says Ragsdale. This is when a scammer includes a piece of information about you in an email to make it look more legitimate. Don't click links or download documents from emails that are unexpected, look suspicious or come from an unfamiliar source. When in doubt, consult an information technology professional, and don't open the email until you have thoroughly researched the sender.

This ends Mr. Ragsdale's article and relevant recommendations. **Remember**, this article is directed primarily to **you** for your personal security. It is not meant to cover all business possibilities, although I can see that many of these will work in your companies as well. I also have a few other recommendations that I feel you need to consider and be aware of the possibilities for exposure:

Shopping on the Internet - While I realize this is the current craze and apparently the preferred retail shopping mode for the future, I am dismayed. In my opinion it should be avoided wherever possible. The more information out there on the internet, the more likelihood that you could be targeted. I do realize that for many transactions, business cannot be conducted unless you agree to order and pay over the internet; so, shopping on the internet cannot be entirely avoided.

Use of the Social Media – Personally I don't use the social media since I think it provides a "smorgasbord" of valuable personal data for the scammers. However, I also realize that Facebook, Linked-In, Twitter, Instagram, etal are here to stay, and there will probably be many more created in the near future. I just say be careful what you post; don't provide personal information (e.g. where you will be at any particular time, personal addresses and phone numbers, etc.).
