[Lincoln Trail Council](#) is offering two \$750 scholarships to undergraduate and graduate students to cover one-day registration cost to attend IMA's Annual Conference & Expo in Indianapolis on either June 18 or 19, 2018. Applicants must be: (1) an IMA Member affiliated with a chapter in the [Lincoln Trail Council area](#) and (2) a junior or senior undergraduate student majoring in accounting or finance or a graduate business student currently enrolled in classes.

Deadline for applications is April 27, 2018; however, scholarships will be awarded on a "first-come, first-serve" basis based on qualifications so earlier submissions are encouraged. The scholarships will be announced no later than May 7. Upon notification, recipients must then (1) complete at least one-day conference registration for either June 18 or 19 and (2) provide proof of registration by **May 14**, or the scholarship will be forfeited. The Council will provide \$500 of the registration funds after receiving proof of registration and the other \$250 will be provided at the conference.

Recipients must also provide a brief written report after the conference regarding the benefits received by attending the conference. Scholarship recipients must reimburse Lincoln Trail Council scholarship funds if they do not fulfill all requirements, including attending the conference and providing brief post-report.
