**GARY LIDDLE** started his career as a civil engineering cadet with the Country Roads Board (now VicRoads). He was appointed Chief Executive in 2007 and has 40 years of experience with the organization. Under Gary's leadership, VicRoads is tackling the challenges of an ever changing transport landscape head on, moving people around Victoria in ways which are socially, environmentally and economically sustainable. He was instrumental in VicRoads being the first government agency to adopt the Sustainable Action Initiative, VicRoads Eco-Office challenge.

Gary is also Chair of the board overseeing the Council of Australian Government's road reform plan looking at the feasibility of mass-distance location pricing for heavy vehicles. Gary is also a member of the Project board guiding establishment of the National Heavy Vehicle Regulator.
