III. Treasurer's Report – Donna Mallonee – Reported by Michael Gallo

- a. As of April 30, 2015, the Section's fund balance was \$59,626.36
- b. The 2014-2015 income for the fiscal year to date aligns with budget expectations, while expenses are significantly below the amount budgeted.

V. Committee Reports

- a. **8**TH **Annual Information Technology Law Seminar** Michael Gallo
 - i. A task level project plan for this year's event was created, and is being revised as additional tasks and timing revisions are identified. The plan includes target dates for each task.

- ii. Seminar 'save the date' information was posted on State Bar's website Calendar, as well as various IT Law Section sources, including LinkedIn, web pages, and an email to the Listserv
- iii. Mark Malven, Ron Nixon, Charlie Bieneman and Keith Cheresko met to discuss topics and presenters. Topics may include:
 - 1. Privacy and Data Protection is Not Just for Clients. Planned as a panel discussion, which may include Bob Rothman, Keith Cheresko and Vincent Polley
 - 2. Technology Buyers Panel What Do Buyers Really Care About
 - 3. Basics of Intellectual Property Protection for Software
 - 4. Open Source Software What Every In-House Counsel Needs to Know
 - 5. The Payment Card Industry (PCI) and Other Electronic Payments Topics
- iv. Attendee materials
 - 1. Need firm due date for speaker materials, to ensure binders are available by Seminar date
 - 2. Decision was made to proceed with spiral bound materials, which are less expensive and require less lead time (about two weeks).
 - 3. For reference: A three ring spiral binder from Staples will cost \$10-12 per binder, plus assembly cost. Lead time required is about four weeks. Mark Malven may be able to provide this service 'at cost' through Dykema, with a shorter required lead time.
- v. Michael Gallo requested and received permission from Chairs of the Business Law Section, Intellectual Property Law Section and Litigation Section to send eBlast and US Mail flyer to members of those Sections. The approvals were sent to the State Bar of Michigan, along with a request for information about the 'SBM Standard Design Registration Flyer' format. About two months were required to get 2015 approvals. Plan accordingly in 2016!
