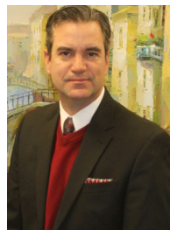
Judge Deborah Geraldine Bledsoe Ford

Judge Bledsoe Ford has served on the 36th District Court since 2004. Her legal career has included positions with the Juvenile Defender's Office, city of Detroit Law Department, clerk to federal Judge Julian Cook at the U.S. District Court, and private practice as a trial lawyer. Judge Bledsoe Ford is a 1981 graduate of the Boston College School of Law. She holds two master's degrees from the University of Michigan and a bachelor's degree from Spelman College in Atlanta. Judge Ford is the daughter of the late Geraldine Bledsoe Ford, the first African-American female judge in Michigan (1966) and one of the first women judges in the country.
