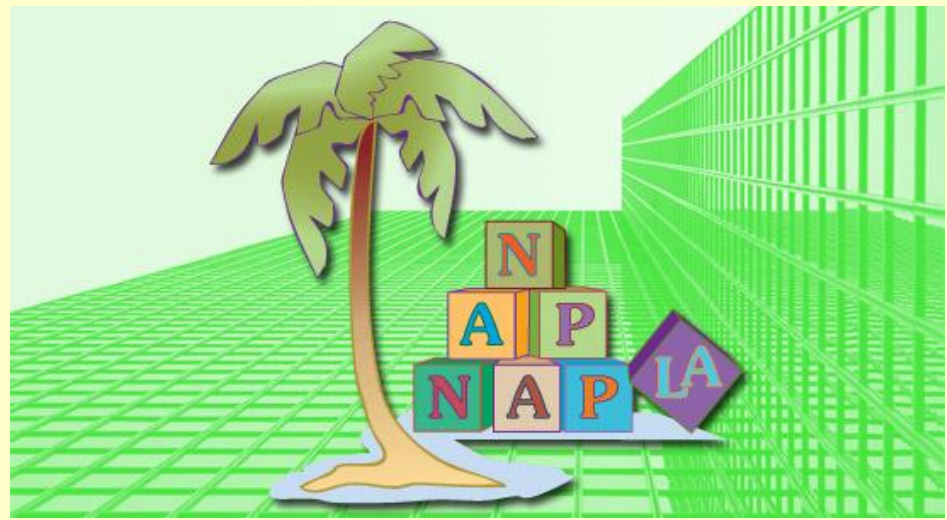

NAPNAP-LA Presidents' Update November 2010

Adolescents comprise a growing percentage of the population in the United States. This age group can be challenging to work with and can present with a variety of health issues. According to the Centers for Disease Control and Prevention, the 3 leading causes of death in adolescents 15-19 years of age include: accidents, homicide, and suicide. Approximately 11% of teens do not have health insurance and

6.7% have no usual source of health care. Common issues in this population include: obesity, eating disorders, recreational drug use, pregnancy, sexually transmitted diseases, depression, and other mental health problems.

The Program Committee of NAPNAP-LA decided to dedicate this year's annual conference to adolescent medicine. Please mark your calendar for Saturday, February 12, 2011 at Long Beach Memorial Medical Center and join us for ***Reflections on Teen Health***. You won't want to miss our expert speakers!

Leo Mascarenhas, MD will present, "Common Malignancies in the Adolescent – When to Refer." Dr. Mascarenhas is an Associate Professor of Clinical Pediatrics at the University of Southern California Keck School of Medicine and the Director of the Clinical Trials Office in the Childrens Center for Cancer and Blood Diseases at Childrens Hospital Los Angeles. He recently received the inaugural Walter Laug Distinguished Teaching Award which recognizes clinical and research faculty members who promote an exemplary learning environment and nurture the ethical, professional and personal development of Hematology/Oncology fellows at Childrens Hospital Los Angeles. Dr. Mascarenhas' areas of research include: clinical research and developmental therapeutics for bone and soft tissue sarcomas.

Kynna Wright-Volel, PhD, RN, MSN, MPH, CPNP will speak on "Obesity in the Teen and Associated Co-Morbidities". Dr. Wright-Volel is an Assistant Professor at the University of California, Los Angeles School of Nursing and also a Robert Wood Johnson Foundation Nurse Faculty Scholar. She also works in the Hematology-Oncology Department at Childrens Hospital Los Angeles as a Pediatric Nurse Practitioner. She recently was awarded

one of five Minority Health Community Trailblazer Awards which recognizes leadership in improving the health of their awardee's respective population, and pioneering contributions that have been outstanding and unique, and whose efforts have "blazed a trail" in the community. Dr. Wright-Volel's research interests include: pediatric chronic health conditions, particularly childhood obesity, racial and ethnic disparities in health, and access and utilization of health care services for children.

Diane Tanaka, MD will present two topics: "Teen Contraception" and "Recreational Drug Use". Dr. Tanaka is an Assistant Professor of Pediatrics and the Coordinator of Resident Training in Adolescent Medicine at Childrens Hospital Los Angeles. Her research interests include: contraception and substance abuse.

Bill Sanders, PhD will present on Gangs and Teens. Dr. Sanders is an Associate Professor in the School of Criminal Justice and Criminalistics at California State University, Los Angeles. In 2008, Dr. Sanders completed a National Institute on Drug Abuse (NIDA)-funded pilot study exploring health risks, including risk of exposure to HIV and hepatitis C, associated with substance use, violence, and sexual behavior amongst gang-identified youth in Los Angeles. Through this and similar research, Dr. Sanders is promoting a public health agenda for the study and approach towards gang youth. He has also published on drug selling, qualitative research methods and gang intervention. His book on young offenders in London, *Youth Crime and Youth Culture in the Inner City* (2005, Routledge) won the 2006 Scholar's Choice Award from the Society for the Study of Social Problems.

Bryna Kane, MD, will present on Dermatology and the Teen. Dr. Kane is an Assistant Clinical Professor of Medicine/Dermatology at both UCLA and UC Irvine. She is the founding partner and co-owner of the Laser Skin Care Center/Dermatology Associates in Long Beach. Dr. Kane has been selected as one of America's Top Physicians/Best Doctors from 1996 to 2008. She has been featured in articles in *Time*, *Newsweek*, *The Los Angeles Times*, and *The Chicago Tribune*, as well as *The California Medical Magazine*, which featured her as a medical hero. Dr. Kane has lectured on several occasions at the NAPNAP-LA Annual conference and is a frequently requested speaker both locally and nationally on her experience and expertise with gang tattoo removal.

The Program Committee is also soliciting the support from a number of vendors. During the lunch hour, we will be presenting Pal of the Year and One of Our Own. Legislative Update – November 2010

Hello fellow NANPA members!

The Legislative Committee would like to take this opportunity to introduce our new Legislative Chair-Elect, Demetra Bastas. She is a Family Nurse Practitioner, who is currently practicing and managing a Family Quality Health Clinic (FQHC) satellite site in downtown Long Beach. She strongly believes in advocacy as a way to raise awareness regarding local, state, and national issues, as well as advance the profession of nurse practitioners as Primary Care Providers. Demetra will be working with our current Legislative Chair, Joana Duran, on our advocacy efforts until she takes over this role next year.

With elections quickly approaching, NAPNAP has been hard at work raising awareness regarding state and federal bills affecting children's healthcare and well-being. We would like to focus this newsletter on spotlighting a bill that has recently passed in the state of California. AB 12, otherwise known as California Fostering Connections to Success Act, was introduced by Assembly Member Beall and Speaker Bass, and sponsored by the John Burton Foundation. This bill was inspired by the harsh reality that annually, around 5,000 young people emancipate from California's foster care system. "Emancipation" is defined as reaching the age at which foster care benefits and services are no longer provided. AB 12 reports that "youth who age out of foster care have lower educational achievement and are more likely to experience homelessness, unemployment, unplanned pregnancies, and involvement with the legal system." Despite the evidence that we can positively impact the trajectory of an adolescent's lifespan, federal and California foster care assistance currently stops at age 18 or 19, failing to provide a successful transition into adulthood. Assembly Member Beall and Speaker Bass wrote this bill in an effort to transform the California child welfare system to better serve foster youth struggling to become self-sufficient adults. The bill accomplishes this by (1) providing transitional support to qualifying foster youth and their caregivers until age 21 instead of only 18, and (2) using federal funds to re-enact the California Kinship Guardianship Assistance Program (Kin-GAP) to assist foster children living with relative guardians.

What is amazing about AB 12 is that the changes represent both fiscally and socially responsible improvements to California's foster care system. AB12 not only facilitates a healthier and more successful transition for the foster youth struggling to make a successful transition into adulthood, but also allows the state to utilize available federal funds to lighten its financial burden. Previously, programs like Kin-GAP were

unsustainable, since all costs associated with it were borne by the state of California. With the use of federal funds, California hopes to meet costs currently supported by the state and counties, as well as alleviate the cost burden associated with the decline in unemployment, homelessness, teen pregnancy, public assistance, and homelessness associated with early emancipation.

As Pediatric Nurse Practitioners and Primary Care Providers, we are clearly concerned with the health and development of teenagers, and their transition into adulthood. This bill is of particular interest to those of us who work with chronically ill teens, who experience enough difficulties in transitioning into adulthood as it is, and would significantly benefit from additional assistance between the ages of 18-21. We fully support and applaud the signing of AB12, and look forward to monitoring its effects over the years to come.

In other news, we would like to report that the Legislative Committee is in the final stages of launching the California State Legislative Tracker for legislation concerning children's health and well-being. The tracker will be available through our local chapter website, as well as the national website, and will monitor approximately 40 active bills concerning issues that are of interest to our organization. Please stay tuned for updates on these developments, as we are looking forward to them!
