- Ensuring contracts made with vendors doing work for the City provide maximum financial protection, and properly identifying and mitigating risks presented to the City
- Working with adjusters, lawyers, and Corporate Security personnel to provide loss prevention/reduction recommendations to departments
- Investigating repetitive claims
- Analyzing and approving performance bonds, letters of credit, insurance requirements, and other financial guarantees to ensure protection from financial loss
- Reviewing contracts from all departments to ensure requirements are met and follow corporate standards
- Maintaining a database of insurance records for vendors and contractors
- Assisting with the Corporate Risk Inspection program
- Maintaining accurate files and statistics, as well as maintaining safe keeping of letters of credit and surety bonds
- Performing related duties as required
