A copy of the first page of our constitution is also attached. This page sets out the objectives of the Society. If you would like more information please contact:



CONSTITUTION AND BY-LAWS
OF
SASKATCHEWAN RISK & INSURANCE MANAGEMENT SOCIETY

ARTICLE I - Name and Offices

The name of this organization shall be "Saskatchewan Risk & Insurance Management Society" (hereinafter referred to as the Society) with Head Office in the City of Regina in the Province of Saskatchewan. The Society shall be deemed to be the Saskatchewan Chapter of the Risk & Insurance Management Society Inc. (hereinafter referred to as the National Society).

ARTICLE II - Objectives

The objectives of the Society shall be:

- a) To make known the needs and viewpoints of Risk & Insurance Management and to promote the free exchange of ideas with all who have an interest in the insurance business.
- b) To foster a close relationship among its members to provide an opportunity to exchange ideas and to consult with each other for a better understanding of the functions of Risk & Insurance Management.
- c) To cooperate with producers, underwriters, regulatory bodies or agencies, or others to secure:
 - (1) Simple and more adequate policy forms.
 - (2) Insurance protection for all insurable risks.
 - (3) Adjustment of inequities in rates, and
 - (4) Adequate recognition of all factors which enter into rating of risks.
- d) To support education programs for Risk & Insurance Management.

ARTICLE III - Membership

Section I Classes

- a) Membership shall consist of corporations, persons or other entities who subscribe to the objectives of the Society, agree to abide by its obligations and who are admitted members by the Board of Directors. Membership shall not be open to those who are engaged in underwriting, selling, regulating or rating insurance or in the investigation or settlement of losses or in the business of
