**GENERAL SUMMARY/OVERVIEW STATEMENT:** Summarize the nature and level of work performed.

The Cardiac Rehab Nurse, under the general supervision of the Nursing Director, functions as an ambulatory practice nurse for the Cardiac Rehab Program. She/he will collaborate with attending physicians, mid-level practitioners, administrative support staff, and other members of the patient care team to achieve optimal clinical outcomes.

The Cardiac Rehab RN works with cardiac patients who have heart disease or have had a procedure to treat their heart disease. The RN monitors patients for changes in their heart conditions and collaborate with a team to develop individualized care plans.

This is a 24-hour position, typically scheduled as three 8 hour shifts per week.

**PRINCIPAL DUTIES AND RESPONSIBILITIES:** Indicate key areas of responsibility, major job duties, special projects and key objectives for this position. These items should be evaluated throughout the year and included in the written annual evaluation.

- Provide nursing care for patients during cardiac rehabilitation, PAD supervised exercise and cardiac lifestyle programs.
- Organize, prioritize and manage your own panel of 20-30 patients, with support from a multidisciplinary care team of exercise physiologists, nutritionists, and cardiologists.
- Perform initial intake interviews for patients interested in the program. Develop a personalized treatment plan for each patient.
- Oversee patient treatment plans and provide expertise in case management including cholesterol and dietary management, smoking cessation, and behavior/lifestyle modifications.
- Evaluate patients' overall health, with special attention to cardiovascular function and metabolism.
- Record blood pressures and patient condition. Observe indications of positive tests or other complications.
- Perform pulse oximetry.
- Review progress towards heart health goals with patients including a home exercise plan.
- Supervise exercise sessions. Use telemetry to monitor and record patients' heart activity for inappropriate responses.
- Collaborate with team Exercise Physiologist to prescribe ACSM protocols for exercise in the cardiac population. Maintain a knowledge of ACSM exercise prescription protocols.
- Advise patients about nutrition, risk reduction, and ongoing exercise regimens.
- Immediately report any new, changing, and/or significant conditions to the supervising physician.
- Initiate ACLS measures and/or emergency care according to department policy.

- Write and perform monthly follow up for Individual Treatment Plans, as required by CMS/AACVPR.
- Teach group education classes for traditional and intensive cardiac rehab programs.
- Conduct group meditations.
- Use Motivational Interviewing skills to promote lifestyle changes related to exercise, nutrition, tobacco cessation, and stress management.
- Attend and participate in staff meetings, educational programs, and other activities to remain current in the field of cardiac rehabilitation.
- Maintains and follows patient care protocols.
- Performs other duties, as directed.

- Comfort in a practice environment that promotes patient-centered care.
