B. Association Summary Report S.Roble, President President Roble reflected on her time well-served as association president and made the following remarks,

It is hard to believe that a year has gone by since being installed as your Affiliate President. It has truly been an honor and a privilege to serve and lead the Association and I am thrilled to continue in this role through the Annual Conference in 2024 as we all collectively strive to elevate FCS throughout the Commonwealth.

In June of 2023, the Board of Directors and Advisory Board Members met and established the Association goals for my term as affiliate president. Those goals were as follows:

- Prioritize communicating with key stakeholders from members of our Association to State Legislatures -- keeping all those connected to FCS informed through a variety of means -- from phone calls to social media posts.
- Provide opportunities for our membership and FCS professionals to participate in professional development as this gives them the opportunity to learn and apply current and relevant research and practices to their professions.
- Address the 3 Rs of membership: recruitment, retention and recognition.

I would like to recognize the commitment and dedication that I have seen with the participation of committee work through this year in addressing these three goals.

C. External Relations Committee Update

M. Tweardy, Chair



External Relations Committee chaired by Michelle Tweardy collaborated throughout the year to support, advocate for and connect our members to professional resources, advocacy efforts and community partnerships. Committee members worked well together on the following accomplishments:

- The PAFCS HUGS mentor program sponsored 6 post-secondary student memberships and matched students with PAFCS members as their mentors. The HUGS group met 3 times virtually. The meetings were interactive and allowed time for students and teachers to connect. The GEMS program was also developed to assist new FCS professionals with membership and mentorship.
- Committee members participated in the National Partnership for the Recruitment, Preparation and Support of Family and Consumer Sciences teachers and professionals; PDE Academic Standards Revision Committee in 2023, and PA FCCLA regional and state meetings.
- Presentations to promote PAFCS activities and the FCS Peer Mentor Program were given at the AAFCS Fall Leadership Workshop in October 2023, LEADFCS Annual Conference in January 2024, and PA FCCLA State Leadership Conference in March 2024.
- PA State Action Team leaders coordinated with the Northeast Network on monthly meetings and hosted the FCS Virtual Conference in March 2024.
- Letters of support for family and consumer sciences programs were sent to PA school
 district superintendents and university leadership at Indiana University of Pennsylvania,
 Messiah University and Pennsylvania State University.
- The committee created and maintained multiple resources, including the statewide job opening announcement list; a contact list of Community Partnerships and Organizations; an FCS resource flyer to share with new teachers, schools and administrations; and the beginning of a course catalog of FCS-content specific course offerings in Pennsylvania.
- We continued to advocate for PAFCS, our members, future educators and our profession at local, regional and national events.

D.) The Membership Committee is chaired by Pat Hetrick.

There are currently 112 PAFCS affiliate members (21 First Year members) (28 Emeritus and Lifetime members) (8 students)

Members with lapsed membership with 15 years or less are being contacted by the committee and Board members to determine the cause of the lapse in membership and invite to attend conferences.

The committee along with Scott Swinehart, a financial advisor have reviewed the Association's funds and investments to ensure that we are acting in a manner of fiscal responsibility. Income and expenses are reviewed routinely by the treasurer, finance committee, and executive director for transparency and accountability.
- **G.)** The Nominations Chair, Joan Hammond, attended several meetings and discussed ways to increase membership with an eye on increasing the pool of potential board members. The nominating committee worked diligently to fill all the board positions for the term 2024 2026. Newly elected officers will be installed today. At this time, I would like to thank all BOD and Advisory Board members for their time dedicated to elevating FCS throughout their term. My sincerest thanks for all you do for PAFCS.
- **H.)The Policies and Procedures Committee,** chaired by Mercy Ross Affiliate Past-President, completed the review process of the Association's Policies and Procedures Manual as well as the PAFCS Bylaws with the Revisions committee. In January 2024, proposed amendment changes were provided to the BOD and Advisory Board Members for review. Members of the Association were notified 30 days prior to the conference to review the proposed bylaw amendments as they will be brought forth to a vote today during the business meeting. The proposed changes are available to be reviewed on the PAFCS website.
- I.) The Professional Development & Programming Committed, chaired by Pat Hetrick, has offered a variety of Act 48 professional development and programming opportunities throughout this past year. Morgan Ferzack, Wester Area Vice President hosted PittsburghFashion Week- Runway Show & Afterparty on September 15, 2023-and on October 14, 2023, she hosted 'Burg Bits & Bites Food Tour. Lisa Golding, South Central Chair, planned a Professional Development and Networking Evening event at Messiah on October 30, 2024. This event was held in conjunction with an effort of Messiah University to educate prospective high school students about the family and consumer sciences major. The final event of the Fall, was planned by Eastern Area Vice President, Jean Kelleher and held at Parkland High School on November 4, 2023.

Act 48 opportunities this Spring include the PAFCS Conference being held at The Central Penn College Conference Center from April 12 - 13, 2024 and for the Runway Repurposed Upcycled Fashion Show being held in Pittsburgh and benefiting the Salvation Army's Family Caring House in May.
