Kansas Statewide Articulation Agreement for Interior Design

This Articulation Agreement between Kansas State University ("KSU") on behalf of its Interior Design Program in the College of Human Ecology and the Kansas State Department of Education ("KSDE") will provide admission to the Interior Design program at KSU to all Kansas high school graduates in accordance with the following:

- 1. A student who graduates from a Kansas high school may apply for admission to KSU. Once admitted, eligible students will be accepted into the Interior Design Program in the College of Human Ecology at KSU upon meeting the following criteria:
 - a. Graduation from a Kansas high school with a minimum of a 3.0 non-weighted GPA on a 4.0 scale and:

- 2. Students admitted to KSU pursuant to this Agreement are subject to the same institutional policies and procedures as currently enrolled students of KSU.
- 3. KSDE and KSU agree to:
 - Coorperate in communicating with each other concerning the relationship between the institutions, courses offered to Kansas high school students, and articulation of students to KSU.
 - b. Acknowledge and recognize this Agreement on each institution's website and via other marketing and publicity methods, but shall not otherwise use the name, trade name, trademark, or any other designation of the other party, or any contraction, abbreviation, or simulation of any of the foregoing, in any advertisement or for any commercial or promotional purpose without the respective party's prior written consent in each case.
 - c. Promptly communicate with each other any changes to the applicable curriculum or resident credit requirements that will affect this Agreement. The parties acknowledge that any such changes may require renegotiation or termination of this Agreement.
 - d. KSDE and the Dean of the College of Human Ecology as well as the Head of the Apparel, Textiles, and Interior Design (ATID) Department at KSU will serve as points of contact for administration of this Agreement.
- 4. The term for this Agreement will commence when all signatures are present. This Agreement shall renew automatically from year to year. Either party may terminate this Agreement upon thirty (30) days written notice to the other party.
- 5. This Agreement constitutes the entire agreement between the parties, and all prior discussions, agreements and understandings, whether verbal or in writing, are hereby merged into this

- Agreement. This Agreement may be revised or modified only by written amendment when both parties agree to such amendment.
- 6. KSDE and KSU agree and acknowledge that they are independent contractors, and the agents, representatives, or employees of one party shall not be considered agents, representatives, or employees of the other party. In no event shall this Agreement be construed as establishing a partnership or joint venture or similar relationship between the parties hereto.
- 7. It is understood by the parties that there shall be no monetary consideration paid by either party to the other.
- 8. The parties shall comply with all applicable laws, ordinances, codes and regulations of federal, state and local governments, applicable to the performance of this Agreement.
- 9. If any provision of this Agreement is held to be invalid or unenforceable for any reason, this Agreement shall remain in full force and effect in accordance with its terms disregarding such unenforceable or invalid provision.
- 10. Any failure of a Party to enforce that Party's right under any provision of this Agreement shall not be construed or act as a waiver of said Party's subsequent right to enforce any of the provisions contained herein.
- 11. The provisions found in Contractual Provisions Attachment (form KSU-146a, rev. 3-18) which is attached hereto, are hereby incorporated in this Agreement and made a part hereof.
