

# **Graduate Fellowship Guidelines Deadline: January 12, 2026**

The American Association of Family and Consumer Sciences (AAFCS) awards graduate fellowships to individuals who have exhibited the potential to make contributions to the Family and Consumer Sciences profession.

# **Applying for the Fellowship**

Before completing a fellowship application, a potential applicant should consider the following eligibility requirements, keeping in mind that each Fellowship may have differing eligibility and/or application requirements as outlined.

- The applicant must be a current AAFCS member at the time of submission.
- To qualify for the national fellowships, an applicant must be a citizen or permanent resident of the United States.
- The applicant is planning to pursue or is currently pursuing a graduate degree in family and consumer sciences or related specialized programs.
- The applicant has applied for admission to begin graduate study, has been admitted to a graduate program, or will be enrolled for the upcoming academic year.
- For the Raitt Fellowship, the applicant is required to attend an Assembly of Higher Education (AHE) or an accredited graduate program. An applicant can confirm if their institution is accredited at https://www.aafcs.org/about/about-groups/higher-ed
- Former recipients of AAFCS Graduate Fellowships may apply for another year of fellowship funding if they meet the criteria of the fellowship(s) for which they are applying, but former recipients are not guaranteed another fellowship.
- Application materials are prepared by the applicant.
- Applicants can submit to only one AAFCS award, grant, fellowship, or scholarship per annual review cycle.
- Members of the AAFCS Board of Directors and Awards Committee are not eligible to apply during their terms of office. AAFCS staff are not eligible to apply during their periods of employment with the Association.
- All award materials must be submitted in English.
- All policies, procedures, and guidelines must be followed for the award application to be considered for juried review.
- Preference will be given to the applicants who:
  - will have completed (at the beginning of the academic year for which the fellowship would be granted) at least one year of professional family and consumer sciences experience, serving in a professional role or in positions such as a graduate/undergraduate assistant, trainee, or intern.
  - o are working on a research problem <u>or</u> can describe a potential research problem for his or her graduate work.
  - o are interested in contributing to the Family and Consumer Sciences profession in the United States, his or her home country, or an international program.

# **Submitting the Application**

The application must be submitted on the official application form and in the order below as one PDF document. Please be aware of the page requirements for each section. Please include page numbers and headings/captions on any supporting materials used. The online application will require submission of a color headshot in PNG or JPEG format of the applicant that will be used in marketing and promotional materials. ## **Evaluating the Graduate Fellowship Application**

- Individuals who complete a Reference Form for a current applicant cannot serve as jurors for this award.
- Jurors cannot review applications from family members, their current students, students at their own
  institution, or applicants who share the same employer. Jurors are responsible for identifying any
  applicants who include a potential conflict of interest and recusing themselves from the review process.
- An individual who has applied for an award, grant, fellowship, or scholarship shall not serve as a juror
  for any award, grant, fellowship, or scholarship during the period in which his or her own application is
  being reviewed.

• Jurors selected by the AAFCS Awards Committee review the applications and assign points using the Evaluation Criteria.

#### **Awarding the Graduate Fellowship**

- The Awards Committee reserves the right not to award a grant, fellowship, or scholarship if jurors do not find a worthy applicant.
- No student will be awarded more than one graduate fellowship in a given year.
- Only qualified applicants who receive a score of 80% or more of the highest score are eligible to receive an AAFCS Graduate Fellowship.
- Recipient(s) will be notified in the spring and will be recognized during the AAFCS Annual Conference. The
  Jewell L. Taylor and Myrna Crabtree Graduate Fellowship recipients are expected to attend the AAFCS
  Annual Conference. These AAFCS fellowships provide additional funding for reimbursement to support
  a year of AAFCS membership and defray some of the travel expenses for participation in the AAFCS
  Annual Conference. The Raitt Fellowship recipient is encouraged to attend the Annual Conference.

# Accepting/Receiving the Fellowship

AAFCS Jewell L. Taylor and Raitt Graduate Fellowships are awarded for the *sole* purpose of providing financial support for academic study in the field of family and consumer sciences. The following will be the responsibilities of those who are *selected to receive one of these AAFCS Graduate Fellowships*:

- Recipient will complete and submit the "Statement of Acceptance" by the given deadline.
- A college or university scholarship officer or academic advisor at the institution where the fellowship
  recipient is enrolled will verify enrollment and eligibility before disbursing the fellowship to the
  recipient in installments—the recipient must remain enrolled to receive fellowship funds.
- Fellowship funds will be sent to a university scholarship officer as designated in the "Statement of Acceptance."
- At the end of the academic year, the recipient is required to submit via email a brief report that indicates how the AAFCS Graduate Fellowship funds were used.

Failure to follow the guidelines will result in ineligibility of the applicant for the award.

# **Evaluation Criteria**

Applicants will be evaluated using the criteria outlined below. Guidelines for what jurors may consider for each criterion are listed for clarity and for consistency in evaluating applications.
