Meet Chef Susan Holding of Little French Bakery at the 2018 WAFCS Pre-Conference



WAFCS Foundation Benefits/Awards Increase in Number and Dollar Amounts

Purpose and Mission of WAFCS Foundation

The purpose of the WAFCS Foundation is to support the purposes of WAFCS. It is a nonprofit charitable organization operated exclusively for scientific, education and charitable purposes and obtains its 501(c)(3) status via AAFCS/WAFCS. It receives and administers gifts and funds generated by fundraising activities. The Foundation's mission is to provide support for student and professional members whose work assists individuals, families, and communities in making informed decisions about their well-being, relationships, and resources to achieve optimal quality of life.

Started with a Scholarship

When the WAFCS Foundation was established in 1990, it had the immediate goal of awarding an annual \$300 undergraduate scholarship. In 1994, Foundation Board members voted to place a moratorium on awarding further scholarships from Foundation funds until a \$30,000 base was reached. Supporters of that vote shared concerns that the base (principal) was being reduced substantially and wished to build it to the point that scholarship(s) could be given mainly from the earnings, thus protecting the principal.

With successful annual fundraising events (Silent Auctions, matching gift offers, quilt raffles, notecard sales, etc.) along with steady donations made in honor, memory, or celebration of individuals, the original goal of \$30,000 was eventually

reached. The Foundation resumed offering an undergraduate scholarship in 1999 and began providing financial support dubbed "travelships" to promote student attendance at WAFCS Annual Conferences.

What about Benefits/Support for Professionals?

The Foundation began to honor WAFCS Award recipients (Teacher of the Year, Leader, and New Achiever) by offering \$300 travelships (later raised to \$500) to support their attendance at the AAFCS Annual Conference in the following year when they are in consideration for national recognition.

The Foundation Board always envisioned being in a financial position to support grants in research or educational projects for professional members in addition to support for students. That became a reality in 2009, when the first \$1000 WAFCS Foundation Professional Project/Research Grant was awarded. Beginning in 2012, multiple grants have been awarded annually.

Current Foundation Benefits Offered to Members

From offering one \$300 undergraduate scholarship annually, fast-forward to the following benefits the Foundation now makes available to WAFCS members. The Foundation also pays the \$425 WAFCS organizational membership dues in IFHE (International Federation for Home Economics) to support our profession at the international level.

For Student/Pre-professional Members:

- \$500 Undergraduate Scholarship (multiple scholarships offered some years)
- \$1000 Graduate Scholarship (first awarded in 2017)
- \$100 Travelship (up to 8) offered to support student attendance at WAFCS Annual Conference
- \$300 Travelship (up to 3) offered to support student attendance at AAFCS Annual Conference

For Professional Members:

- \$1000 Professional Project/Research Grant (multiple grants offered some years)
- \$125 Stipend (up to 3) offered to promote professional attendance at WAFCS Annual Conference
- \$500 Travelship (up to 3) offered to support professional attendance at AAFCS Annual Conference
- \$500 AAFCS Annual Meeting Travelship to WAFCS Award Recipients (Teacher of the Year, Leader, New Achiever)

Looking Ahead

While interest rates and earnings have remained low in recent years and the Foundation awards more funding than it brings in during the course of its fiscal year, the Foundation is in a position to continue making awards, increase dollar amounts of awards, and add categories of awards. The Foundation is always open to considering new ways of supporting the profession of Family and Consumer Sciences and more specifically, our Association. For example, in 2012, the Foundation made a \$1000 donation to the AAFCS Goebel-Young Leadership Training Endowment Fund earmarked specifically for the AAFCS Leadership Academy.

Your nomination of a non-WAFCS member or an organization is due by December 15, 2017. The nomination process is brief and you are encouraged, but not required, to contact the person or organization you are nominating to help with completing the application.

What is New? The criteria have changed. Listed below are the criteria:

The Wisconsin Friend of the Family Award recognizes a person or an organization for outstanding leadership and service in advancing public policy and/or leadership and support to goals and purposes consistent with Family and Consumer Sciences.

- The Friend of the Family Award is presented to a person or an organization whose work aligns with the vision, mission and goals of the American Association of Family and Consumer Sciences and the Wisconsin Association of Family and Consumer Sciences.
- The Award winner's work is an outstanding example of support and aligned with the research-driven body of knowledge (BOK) for the field of Family and Consumer Sciences.
- The Friend of the Family Award is given to a person or an organization who upholds the Ethical Statement for the American Association of Family and Consumer Sciences.
- The Friend of the Family Award is given to a non-member of WAFCS in the state of Wisconsin.
- The Friend of the Family Award winner agrees to attend the WAFCS State Conference to receive the Award.

 Additional family members attending the award ceremony are invited and will be asked to pay for their meals, if they are attending the banquet. This award is presented at a banquet or luncheon, lodging and transportation fees are not paid for the awardee or their guest(s).
- The nominator(s) will prepare a presentation highlighting the leadership and service of the Friend of the Family Award winner. The gift/token and a certificate will be awarded by the President of WAFCS and the nominator(s).

Mary Kaye Merwin will be inducted into the National 4-H Hall of Fame on October 6, following 37 years of teaching, directing programs and professional development in the organization.



Student named collegiate representative to national council

September 15, 2017

A University of Wisconsin-Stout student recently was appointed to the National Council of Phi Upsilon Omicron as a collegiate representative — one of four selected across the nation.

Kennedy Navis, of Cedar Grove, Wis., a junior studying family and consumer science education, will represent Region 1 with the Tau Chapter. She is also the co-president of the chapter this year.

Phi U is an honor society of family and consumer sciences. Students in good academic standing are invited and encouraged to join. Furthermore, students who accept are initiated and can participate in community service work and gain valuable leadership skills, while developing connections on and off campus.

"It's kind of funny how it all happened," Navis said of her national council appointment.

Prior to Navis being named, the collegiate representative for Region 1 stepped down. In the midst of searching for a replacement, UW-Stout's Phi U adviser Carolyn Barnhart strongly suggested Navis as a good candidate.

"She's standing tall among leaders on our campus and also nationally," Barnhart said. "She will be able to advise the council and the entire association of the needs of the students."



Navis is now the voice of thousands, representing 25 chapters in her region — stretching from lowa to the northern tip of Maine.

She represents the student voice and is responsible for communicating with the national council and organizing conclaves. Conclaves are networking events at which chapter members from around the U.S. share skills, projects and listen to guest speakers.

As a collegiate representative, Navis will attend a board meeting of the national council in Kansas City, Mo., to plan the next conclave, which will take place in Boston, Mass.

As a member of the honor society, Navis and her UW-Stout colleagues recently placed second nationally with Leadership through Service: Spread the Love, their professional project, which involved working with Cardz for Kidz and Operation Care 4 R Troops.

The UW-Stout honor society also worked with the Stepping Stones local food pantry and local nursing homes. Navis has also received an award of her own, a Phi U scholarship for the 2017-18 academic year.

Navis emphasized that being a part of Phi U is a chance to make a difference in the community and a great way to build relationships and leadership abilities.
