The FOW Award recipient's work aligns with the vision, mission and goals of the Wisconsin and American Association of Family and Consumer Sciences and is an outstanding example of support for the field of Family and Consumer Sciences (FCS). The FOW Award is given to a non-member of WAFCS. This award was previously named The Friend of the Family Award.

The recipient of the FOW Award is invited to attend the Awards Banquet at the WAFCS Annual Conference where the VP of Awards and Recognition will present the award. Additional guests may attend but will be asked to pay for their meal cost.

#### Awards Process:

- WAFCS member(s) will nominate a person, organization or business for the Friend of WAFCS Award.
- WAFCS member(s) is/are expected to work with the nominee in completing the FOW Nomination Form.
- The completed FOW Nomination Form is forwarded to the VP of Awards and Recognition. A committee is established to review the nomination using the criterion found on page 3.
- The name of the Friend of WAFCS Award recipient is forwarded to the WAFCS President and Conference Chair(s) where upon approval by the Executive Committee, it will be used for planning the Awards Banquet.
- Following the WAFCS Annual Conference the VP of Awards and Recognition prepares an article for the upcoming WAFCS e-news.
- The Friend of WAFCS Awardee will receive the WAFCS e-news for one-year.
