Medicine During the Holocaust and Its Contemporary Relevance: Perspectives from Health Professions Students

David J. Skorton, MD, AAMC president and CEO, will provide opening remarks.

Celebrating the Role of Arts and Humanities in Medical Education

On Oct. 28, the AAMC hosted a celebratory event as part of the FRAHME initiative and in recognition of National Arts and Humanities Month. Participants heard from Sacha Sharp, PhD, MA, assistant professor at Indiana University School of Medicine, who developed the "Health Equity Using Art" program. This program is designed to increase awareness and empathy while identifying bias against those underserved in medicine. Dr. Sharp participated in the pilot of the "Humanities and Arts Program Evaluation" course developed by the AAMC. Using the Performing Arts to Teach Medical Competencies

The FRAHME Getting Started Guide is designed for educators who are new to incorporating arts and humanities into their programs, courses, or curricula. The Guide provides specific ideas and examples for integrating the arts and humanities into competency-based medical education. Activities were selected due to their ability to be conducted at low cost with any group of learners, regardless of developmental stage or specialty.

The Guide offers examples of how to use <u>Indian dance</u>, <u>jazz music</u>, <u>and improv theater</u> <u>techniques</u> to teach interpersonal and communication skills and how to use <u>film and dance</u> <u>movement</u> to teach patient care and procedural skills

Baylor College of Medicine School of Medicine developed a mandatory narrative medicine course for students that spans spring of second year through fall of third year. Sponsored in part by a <u>FRAHME grant</u>, evaluation research demonstrated statistically significant improvements in areas such as empathic concern, perspective-taking, and well-being.

This initiative was conducted in obstetrics—gynecology and urology residencies at UT Health San Antonio and consisted of three phases: a focus group to identify mistreatment experienced by residents, resident volunteers to create and act out the forum theater scenario, and enactment of the forum theater scenario during didactic time. After 6–8 months, self-reported mistreatment behaviors had decreased.

For the Lost


Tomorrow the sun will rise
