### Arts and Humanities Activities for Diversity, Equity, Inclusion, and Anti-Racism Education

The FRAHME Getting Started Guide is designed for educators who are new to incorporating arts and humanities into their programs, courses, or curricula. The guide provides specific ideas and examples for integrating the arts and humanities into competency-based medical education. Activities were selected due to their ability to be conducted at low cost with any group of learners, regardless of developmental stage or specialty.

Activities for teaching about diversity, equity, inclusion and anti-racism can be found in the section on Systems-Based Practice. Resources include:

- <u>Episode 4 of the 1619 Project Podcast</u>, which details how Black people have been systematically denied access to health care over time.
- <u>The Health Humanities Approach</u>, which pairs patient narratives with humanities scholarship from history or literature. Portraits are offered on the racial politics of gun violence, gender and religious identity in Mexican-American women, and the medicalization of trans lives, among others.
- An AAMC webinar in response to the film "The Color of Care," which chronicles how people of color suffer from systemically substandard health care in the United States.
- The Multiculturalism Reading Guide from Bellevue Literary Review offers stories, essays, and poems, along with discussion questions, to help learners dissect the complexities of multiculturalism as it exists both within a medical context and within society.

### **Surrounded by Black Excellence**

#### Artist's Statement:

"Life-saving" is a term often associated with medicine, but it fails to communicate what about life is being saved. Furthermore, a life that needs saving insinuates helplessness on behalf of the patient. "Life-prolonging" is perhaps more appropriate. The idea of "life-prolonging" care is simple, but with profound implications.

Many medical interventions are known to prolong life. As a medical student, I am tasked with learning about many of these interventions. Almost as often as I find myself in awe of the intricacies of human biology and medicine's healing power, I wonder if patients are able to make the most of the extra time medicine gives them. Medical treatments can vastly improve patients' lives, but they can also bring about financial hardship, disrupt routines, and diminish patients' abilities to do the activities they most enjoy. This dichotomy is reflected in the image of an hourglass being broken to give it more sand – more time.

I am continually humbled by how little I know about each of my patients. As I work to understand standards of care, I know that putting this knowledge into practice will require learning from my patients as well. Many of my questions about how care should be delivered cannot be answered without first considering patient values. I hope this digital painting inspires others to weigh the burdens and benefits of medical treatment, particularly within the context of life-prolonging care.
