



Honorary Fellow Nomination

The American Academy of Nursing (Academy) recognizes a small group of individuals as Honorary Fellows for their outstanding contributions to nursing and/or health care and their significant potential for continuing contributions to nursing, health care, and the Academy. Honorary Fellows may use the FAAN credential and may be called upon by the Board of Directors to advance the [mission and vision](#) of the Academy.

Criteria:

- A nominee for Honorary Fellow is not eligible for membership as a regular Fellow (i.e., not a nurse*);
- They must be sponsored by three (3) Regular Fellows (or special categories of Regular Fellows: Emeritus and Living Legends) in good standing; ** and
- The nominee must consent to be nominated.

Nominations should address the following:

- Describe the extraordinary and sustained contribution of the nominee to nursing and health care (to be completed by each sponsor); and
- Provide no more than two pieces of evidence demonstrating the positive, ongoing, and potential impact of the nominee's work in influencing nursing, health care, and the Academy. *Portfolios are not accepted, not to exceed 25 pages.*

*The nominee must not be currently or previously licensed to practice as a registered nurse.

**Nominating Information: Regular Fellows may sponsor no more than 2 candidates for Fellowship per year, which includes Regular Fellows, Living Legends, and Honorary Fellows.

Deadline and Nomination Fee: This form and nomination fee must be submitted by **May 5, 2023**. Please note only **ONE sponsor** should submit the nomination form on behalf of all three sponsors. However, each sponsor should draft their individual statement as noted above. The completed PDF form, as well as the documents demonstrating evidence (no more than 2), must be emailed to Claire Holland at cholland@AANnet.org.

There is a one-time, non-refundable fee of \$375 per nomination. [Please click here to complete payment](#). Electronic payments must be made at the time of application submission. If paying by check, it must be postmarked prior to the application deadline of **May 5, 2023**. Please note that the Academy can only accept full payment from one Sponsor on behalf of the group. The Academy cannot process multiple payments for the Nomination fee.
