In making this decision, the Board recognized we are still in a transition period. While we are trending in the right direction to weaken the COVID-19 pandemic, its impact is still being felt on many levels.

I heard from so many Fellows how meaningful it was to be able to be a part of the celebration even when we couldn't be together in person. The 2021 conference will incorporate virtual aspects that we enjoyed while also offering new and exciting in-person events. I look forward to seeing the evolution of our health policy conference and ceremonies in a post-pandemic world. I hope that you will join us and continue your active engagement in the Academy!

In addition, and importantly, please be sure to watch for the announcement of the Academy election in the coming weeks. This year we will be voting for the incoming President-Elect, Treasurer, Board members, as well as members for key committees. And at our annual business meeting we will be bringing forward bylaw revisions and reports on the extensive work being done by our Governance Steering Committee, Diversity and Inclusivity Committee, and Fellow Selection Review Committee, among other reports.

In closing, while fall may still be a few months away, the excitement is building for the Board and staff to welcome you to our hybrid event. In August, we will be thrilled to announce the 2021 class of Fellows, Living Legends, and Honorary Fellows. 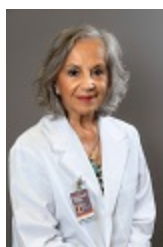
