This tenured faculty position at the full professor level is a named professorship recognizing a distinguished scholar who has made significant accomplishments in research important to nursing as reflected by a sustained funded research program with publications in high-quality, peer-reviewed research journals, and demonstrated excellence in mentoring. We seek candidates with expertise consistent with one or more of the HHS signature areas of Developmental Health and Wellness, Healthy Lifestyles and Vital Longevity, and Sustainable Organizations and Thriving Communities (<https://www.purdue.edu/hhs/research/signature-areas.php>).

Qualifications: A registered nurse with a PhD degree in Nursing or related field and current academic rank of full professor, with tenure or equivalent. Evidence of a well-developed federally funded independent and/or collaborative research program required. Excellent oral and written communication skills and interpersonal skills should be demonstrated. Previous mentorship of researchers across levels is expected and college-level teaching desired.

Application: Application packages must include:

- 1) Full curriculum vitae
- 2) Letter of application describing how qualifications fit the position, specifically addressing mentoring philosophy, research experience, and future research directions
- 3) Statement of Diversity, Equity, and Inclusion (DEI).
- 4) Names of three (3) people from whom references may be solicited, one of which must be a research mentee within the last 5 years. (Applicant will be contacted prior to recommendations being solicited).

Candidates should address at least one of these areas in a separate Diversity and Inclusion statement, indicating their past experiences, current interests or activities, and/or future goals to promote a climate that values diversity and inclusion.
