Category	Code	Description
Consultant/Advisor	C	Consultant fee, paid advisory boards or fees for attending a meeting.

The Program Committee reviews all financial interests for all presenting and senior authors on all abstracts. AAPOS considers Presenting Authors and Senior Authors to have influence over the content of what is presented at the AAPOS meeting. All authors are required to disclose any real or apparent conflicts of interest with ineligible companies (previously known as commercial interests) whose products or services may be mentioned in the activity. The ACCME considers financial relationships to create conflicts of interest in CME when individuals have both a financial relationship with an ineligible company and the opportunity to affect the content of CME about the products or services of that commercial interest.

Indiana Academy of Ophthalmology (IAO) and the American Association for Pediatric Ophthalmology and Strabismus (AAPOS) have determined that a financial relationship should not restrict expert scientific, clinical, or non-clinical presentation or publication, provided that appropriate disclosure of such relationship is made. As an ACCME accredited provider of CME, IAO and AAPOS Joint Provider seeks to ensure balance, independence, objectivity, and scientific rigor in all individual or jointly provided CME activities.

Companies that are ineligible to be accredited by the ACCME System (known as ineligible companies) are those whose primary business is producing, marketing, selling, re-selling, or distributing healthcare products used by or on patients.
