1. CALL TO ORDER

The meeting was called to order at 5:38 p.m. by STT Chair Phil Forner. He welcomed the participants and guests, and thanked them for attending the meeting.

The assembled attendees introduced themselves. A roll call established that there was a quorum.

Mr. Halel advised that the ACCA EI Board of Directors approved, on Sunday, the new Scope for the STT as follows:

The scope of the Standards Task Team, of The Air Conditioning Contractors of America Educational Institute (ACCA-EI) shall be the development of standards that support the indoor environment, commercial refrigeration applications, and energy efficiency. ACCA standards shall promote comfortable, safe, and energy efficient buildings and refrigeration applications by addressing the proper design, installation, operation, maintenance, repair, and replacement of heating, ventilating, air conditioning, and refrigeration (HVACR) equipment. Recognizing that building components and systems function interactively, such standards may include optimizing the whole building as a system. ACCA standards may (1) include requirements for safety, health and well-being, design, installation, maintenance, repair; and (2) may address optimum comfort, safe and efficient operation of buildings; and HVACR systems, and (3) may address performance, or operation, or qualification of personnel.

Mr. Forner noted that ACCA's Anti-Trust Policy was previously distributed and advised that the meeting would be held in accordance with the prescribed requirements.

Mr. Forner thanked all committee members for their service.

Mr. Forner asked if there were any requested changes to the Agenda. None were brought forward. The Agenda was approved as written.

ACTION ITEM: ACCA STAFF TO MAINTAIN / UPDATE THE SIGNIFICANT STANDARDS ACTION TABLE ON THE ACCA WEBPAGE.

4. STG/STANDARDS STATUS

Mr. Halel informed the members of the status of ACCA's Standards:

- **ANSI/ACCA 1 Manual D 2016:** Manual D has been revised and published as ANSI/ACCA 1 Manual D *Residential Duct Systems* Third Edition Version 2.50. It is available from the ACCA Bookstore..
- ANSI/ACCA 9 QIvp Standard 2016: This standard has been published (April 20, 2016) and is available on the ACCA website
- **BSR/ACCA 10 Manual SPS 201x:** The PINS for this was approved in May 2015 and work on the standard is scheduled for late-2017. There are a number of changes to be made. Mr. Forner advised that this standard was referenced in the IAPMO and suggested that ACCA explore getting this standard referenced in the ICC.
- ANSI/ACCA 11 Manual Zr 2011: This manual is next in line for updating consideration.



- ACCA Manual T: A PIN was submitted to ANSI in 2007 notifying them of ACCA's intent to revise the manual and take it through the ANSI process to become an American National Standard. To date, ACCA has not identified a technical expert to take the lead on the revision. Mr. Jackson said he may be able to identify a candidate.
- **BSR/ACCA 15 OBD 201x:** For this new standards development activity (*On-Board Diagnostics Fault Codes HVACR Equipment*), ACCA staff has been participating with an AHRI-created Task Force. The AHRI effort has focused on identifying equipment fault conditions. In early November 2016, an ACCA-developed fault-code scheme was crafted and applied to the list of fault descriptions. AHRI is to approve the release of the fault descriptions so that ACCA can include the information in the proposed OBD standard.
- **BSR/ACCA 16 Manual E 201x:** ACCA is continuing efforts to develop design guidance for low-load homes.
- BSR/ACCA/ASHRAE 180 201X: ASHRAE and ACCA are updating the ANSI/ASHRAE/ACCA 180 2012 (Standard Practice for Inspection and Maintenance of Commercial Building HVAC Systems) Standard. Since its January 2017 meeting (Las Vegas, NV), the committee has been updating the maintenance elements within the various equipment tables and reviewing the frequencies of the tasks.
- **BSR/ACCA/ASHRAE 183 201X:** This joint ASHRAE / ACCA Standard (*Peak Cooling and Heating Load Calculations in Buildings except Low-Rise Residential Buildings*), originally released in 2008 reaffirmed in 2011 and then again in 2014 is to be released for 2017 reaffirmation (no substantive changes being made). A 45-day ANSI-public review is likely to commence in late-summer 2017.
- **BSR/ACCA/ASHRAE 211P 201x:** ACCA and ASHRAE are jointly developing a new standard: ANSI/ASHRAE/ACCA 211P 201x *Commercial Building Energy Audits*. The initial ANSI Public Review for the proposed standard closed on 19 September 2016. There were 387 comments from 72 commenters. The committee is now parsing through the inputs and it is anticipated that the revised standard will be released in mid-2017 for a second public review.
- **BSR/ACCA/BPI QEE 201x:** In mid-2015, ACCA and BPI began joint efforts on a new standard (*Protocol for Quantifying Energy Efficiency Savings in Residential Buildings*; QEE), which is intended for ANSI designation. The QEE Standard is to provide a uniform method for measuring energy efficiency at the portfolio level.

5. OTHER ISSUES / NEW BUSINESS

Mr. Offord stated that earlier Manual J's used to include information on foam walls and encapsulated attics. Mr. Halel opined that Manual J continues to contain information on the use of foamed walls and attics. He added that ACCA previously released a Technical Bulletin that worked out an example for an encapsulated attic.
