Amendments to the Articles of Incorporation:

Purpose:

"The Academy for Eating Disorders is a global professional association committed to leadership in eating disorders research, education, treatment, and prevention."

Dissolution:

"Upon the dissolution of this organization, assets shall be distributed thus by: (1) allocating funds to dissolve the organization and to pay all other outstanding bills; and then (2) distributing the remaining assets for one or more exempt purposes within the meaning of section 501(c)(3) of the US Internal Revenue Code, or corresponding section of any future US federal tax code, to the US federal government, or to a state or local government, for a public purpose."
