Also for the first time this year, the Clinical Teaching Day will include a Research Training Day entitled 'Unlocking the Secrets of a Successful Grant Application'. Many thanks to our speakers for their willingness to share their wisdom and skills in all these sessions.

For the main conference event, starting Thursday, May 2, we are delighted to welcome David Barlow from Boston University as our keynote speaker. Dr. Barlow will set the scene for our conference by bringing insights from the different but related field of anxiety disorders. We are looking forward to hearing what the field of eating disorders might learn from novel psychological approaches to anxiety and other emotional disorders. Emotion remains the theme in our first plenary session, which aims to bring a 'bench to bedside' look at emotional processing in eating disorders. Our second plenary spotlights the increasingly recognized problem of eating disorders among males, and asks 'Where are all the men?'. Our treatment plenary this year will address questions of therapeutic 'fit'; what works best for who, and who might best deliver it. Our fourth and final plenary invites us to open our minds to the possibility that mindfulness and meditation have a useful role in eating disorders prevention and treatment.

In between these plenaries are opportunities to hear about the latest scientific developments, explore new theories, learn new skills and network with like-minded colleagues in an array of scientific paper sessions, posters, workshops, and SIG panels. The ICED planning committee received a record number of submissions this year, so we know that the presentations will be of the highest standards.

And if you have capacity for a little more, be sure to put your most challenging conundrums to leaders in the field in the 'Meet the Experts' session; if you are new to the AED, join the new member breakfast and learn more about the work of the AED; meet the exhibitors and sponsors in the exhibition area; pick up a copy of the Medical Care Standards Task Force brochure, and of Aimee Liu's book, *Restoring Our Bodies, Reclaiming Our Lives*, the proceeds from which she generously donates to the AED. Importantly, we hope that you will join us on Saturday lunchtime for the AED annual business meeting to vote in new members of the board of directors, hear about the work of the AED outside of the ICED, and to celebrate the achievements of those leaders in the field who will receive one of the coveted AED awards. This year too, we celebrate the publication of the Residential and Inpatient Treatment Standards, the work of a dedicated team of AED volunteers working with our partner eating disorders organizations.

If it's discussion and debate that you like, where better than the Research-Practice Think Tank to share your views. This year's think tank will take a cross-disciplinary look at recovery. And if the microphones are all in use, you can join in through Twitter. Research-practice integration is at the heart of the AED's mission, and this popular session is once again the closing session of the conference, leading into the evening social event, where you can relax with colleagues, enjoy a delicious buffet, and dance or chat until dawn.

Among all of this, I hope you take a little time to appreciate the beautiful city of Montréal, with its wonderful history and culture.

Finally, I want to thank the members of the AED for their support and dedication to our organization and our mission. In particular I want to thank all of the Board of Directors, the AED staff team, and the Committee and Task Force chairs and members, without whom none of this would happen.

I hope you leave the ICED enthused and stimulated.

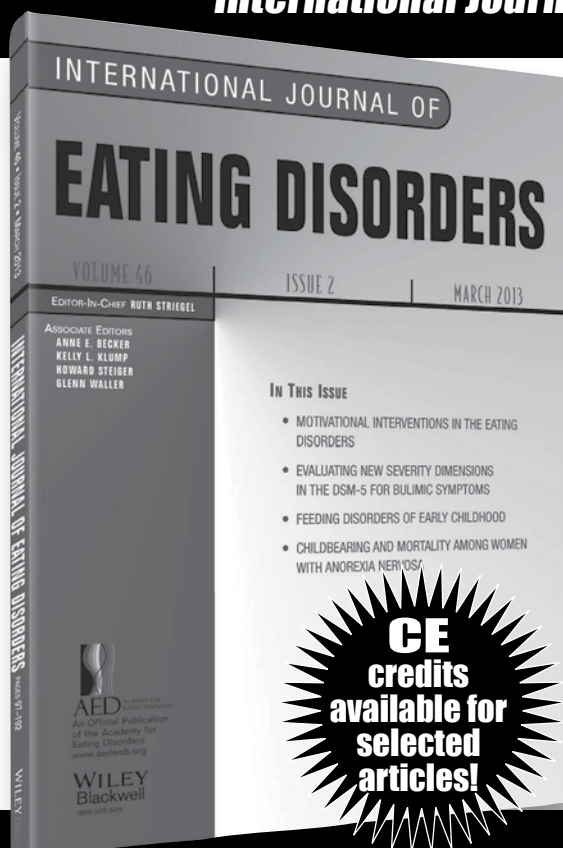
