

# 2026 International Travel & VISA Information

**AEJMC 109th Annual Conference | New Orleans, Louisiana | August 5–8, 2026**

International attendees may need a VISA (or ESTA authorization) to enter the United States. AEJMC can provide an **Attendance (VISA) Letter** to support your visa application. Please review the information below and begin early, as interview appointment availability and processing times vary by country and season.

## Step 1: Confirm What You Need to Enter the United States

Most conference attendees travel under a **visitor visa (often B-1/B-2)** or, if eligible, the **Visa Waiver Program (ESTA)**.

## Step 2: Apply for a U.S. Visitor Visa (If Required)

The U.S. Department of State provides the official steps for applying for a nonimmigrant visitor visa, including completing the DS-160 and scheduling an interview.

## Step 3: Request an AEJMC Attendance (VISA) Letter

AEJMC provides an **Attendance (VISA) Letter** confirming your conference registration and the conference details. This letter is intended for use in your visa application and/or interview.

### How to request the letter

- Request your letter through the [AEJMC conference registration site](#) by selecting “Attendance (VISA) Letter Request.”

- If the request link is not yet available, please check back after registration opens or contact the AEJMC office for assistance.

**Information you should have ready (must match your passport):**

- Full Name (as shown in passport)
- Passport Number
- Date of Birth
- Country of Citizenship
- Affiliation (institution/organization)

**Step 4: Prepare Your Supporting Documents**

Requirements vary by embassy/consulate. Applicants are commonly asked to bring:

- Passport and DS-160 confirmation page
- Visa appointment confirmation
- AEJMC Attendance (VISA) Letter
- Proof of funding (personal, institutional, or sponsor support)
- Evidence of ties to your home country (employment/enrollment verification, leave approval, etc.)
- Conference details and travel itinerary (if available)
