A bachelor's degree and at least five years of progressively responsible major gift fundraising experience are required, with a master's degree and prior higher education fundraising experience preferred.

This leader must embody Pepperdine University's mission of purpose, service and leadership while inspiring generosity and building lasting alumni and donor partnerships.
