- Lead all aspects of identification, cultivation, solicitation, and stewardship for a portfolio of business and corporate funders and prospects, with capacities to invest a minimum of \$10,000.
- Prepare letters of inquiry, grant and sponsorship proposals, and grant reports for businesses and corporations.
- Develop meaningful and compelling engagement opportunities for corporate partners, connecting them to OCSA's mission and impact.
- Serve as lead relationship director for corporate portfolio, and support Executive Leadership with relationship management as needed.
- Collaborate with Development and Marketing colleagues to develop appropriate recognition and to highlight institutional partnerships.
- Ensure compliance with all sponsorship restrictions and reporting requirements, and to gather information necessary for reports.
- Participates with other Foundation team members and volunteers in soliciting donations of highquality auction items and services, as well as table/underwriting sponsors for annual Gala and other Foundation special events.
