#### **6 STEPS FOR GOVERNMENT RELATIONS**

- 1. **Define your needs:** Do you want the government change its law or regulation for your sector? What is not covered by your actual income? What is your operations needs? What projects would you like to realize in the future? What are the expected costs?
- 2. Do your homeworks: What are the programs or government services that could finance your needs?

  Prepare your case for support and show the impact if you realize your project. Statistics and numbers talk.

  Check the official government politics and political platform of the ruling party that you would answer Will you help government to face a challenge that is a priority for them?
- **3. Build up your supports**: If possible, obtain letters of supports from other organizations and partners in your community.
- 4. Identify your contact people: Identify people to contact. On the political spectrum: Mayor-Municipal councilior, your MP-MLA-Minister(s) office(s) political attaché. On the administrative side: municipal, provincial and/or federal level services or ministries in charge of programs you would like to contact for law changes or finance needs. Send those contact a request for a meeting with your case for support and letters of supports.
- **5. Begin the lobby process:** Meet people in person if possible or virtually to exchange on your needs and case for support. Verify if there is still money in the program you want to submit a request, their openess to support your request, what is the main criterias to choose a project and if there is other options you were not aware of.
- 6. Make your follow ups and prepare your requests according to the programs.
