





# **Outstanding Nonprofit Advocate**

# **Amol Sinha**



Since taking the helm of the ACLU-NJ in 2017, Amol has guided the organization through a period of unprecedented growth and influence. Under his leadership, the ACLU-NJ has more than doubled its staff, deepened community partnerships, and built an integrated advocacy model that combines litigation, policy, public education, and strategic communications. The results have been nothing short of transformational for New Jersey's civil rights landscape.

During his tenure, the ACLU-NJ has appeared before the New Jersey Supreme Court more than any other non-governmental party, securing landmark victories across multiple issue areas. Amol has championed access to driver's licenses for all residents regardless of immigration status, prevented hundreds of deportations, restored voting rights to people on probation and parole, and defended free

speech across a spectrum of viewpoints.

One of the hallmarks of Amol's leadership is his focus on decarceration and criminal justice reform. Through strategic litigation and legislative advocacy, the ACLU-NJ helped secure the early release of more than 9,000 people from New Jersey's prisons and jails, a historic step toward dismantling systemic inequities in the criminal legal system. His team also led the successful effort to legalize cannabis with an explicit racial justice framework—ensuring equity remained central to policy and implementation.

Beyond his work at the ACLU-NJ, Amol is a respected national leader. He was elected Chair of the ACLU's Nationwide Executive Director Council in 2024 and serves as a Policy Fellow at Princeton University's School of Public and International Affairs. His career has also included significant roles at the Innocence Project and the New York Civil Liberties Union, where he led efforts to address wrongful convictions, protect immigrants' rights, and reform the criminal legal system.

Amol's influence extends into the community, particularly within the South Asian American and Asian American and Pacific Islander (AAPI) communities. He has served as President of the South Asian Bar Association of New York, been appointed to the New Jersey AAPI Commission, and is a frequent commentator in national and international media on civil rights, racial justice, and public interest law.



# **Outstanding Foundation**

# **Connie Dwyer Breast Cancer Foundation**

For more than 20 years, the Connie Dwyer Breast Cancer Foundation has been a beacon of hope for thousands of uninsured and underinsured women. The organization's mission is clear and powerful: to ensure vulnerable women have access to high-quality breast health services—regardless

of their ability to pay. Through clinical care, education, advocacy, and financial support, CDBCF addresses every stage of the breast cancer journey with compassion and precision.



One of the Foundation's most impactful initiatives is its

Community Grants Program, which dramatically expanded in 2024. That year, CDBCF awarded \$100,000 to eight exceptional organizations, each dedicated to preventing, diagnosing, treating, or supporting recovery from breast cancer. Together, these community partners served more than 7,000 patients and families statewide. From financial aid and transportation to emotional recovery and holistic healing, these programs touch lives in meaningful, lasting ways.

#### Among the 2024 highlights:

- · Sister to Sister offered financial assistance to over 2,200 women.
- · Crossroads4Hope delivered bilingual outreach and education to 4,000 individuals.
- Trinitas Foundation helped 60+ patients access lifesaving care through transportation assistance.

CDBCF's visionary leadership and commitment to equity were also instrumental in launching a \$1.2 million mobile mammography unit at University Hospital in Newark in 2024. Outfitted with state-of-the-art 3D technology and a full-time outreach team, the unit screened 2,365 women in its first year, with projections to reach more than 4,000 annually. For women facing barriers such as poverty, language, or lack of insurance, this mobile clinic brings care directly to their neighborhoods—removing the systemic obstacles that often delay diagnosis.

The Connie Dwyer Breast Cancer Foundation exemplifies what it means to be an outstanding foundation: innovative, compassionate, community-centered, and relentlessly committed to saving lives. By lifting up trusted partners, removing barriers to care, and expanding access to vital services, CDBCF brings hope and healing to women who need it most.



# **Outstanding Community Organization**

# **Creative Comfort Pet Therapy (CCPT)**

Founded in 2011 by the late Joan Baer and Annie Murphy, CCPT was created to meet the soaring demand for animal-assisted visits across New Jersey. What distinguishes CCPT is its hands-on, customized approach: staff collaborate with every partner site to match the right volunteer–pet team to each population's needs, then structure every visit for maximum therapeutic impact.

#### Numbers That Tell a Story

- 7,000+ visits in 2024.
- 150.000 people reached.
- · 300 facilities served across nine counties.
- 500+ certified teams representing dogs, cats, rabbits, guinea pigs, a goat, and even a mini-horse.



Behind those numbers are the volunteers who commit to at least two visits a month after passing a rigorous evaluation and mentorship process. Together, they deliver about 300 visits every month to hospitals, schools, libraries, mental-health programs, veterans' homes, hospices, and senior-care centers.

Research shows interaction with calm animals can lower blood pressure, release mood-boosting endorphins, and diminish pain. Yet the magic often reveals itself in personal moments:

- · A child with selective mutism whispers to a therapy dog for the very first time.
- · A stroke survivor flexes stiff fingers to reach a cat's soft fur.
- An elder in memory care brightens, recalling the therapy dog's name even after forgetting her own.

"These animals reach people no one else can," says a CCPT staff member. "Healing can begin with a single tail wag."

Mission: To enhance people's lives through therapeutic visits with caring volunteers and their pets.

Vision: A statewide network where trained volunteers and facilities connect easily, and the benefits of pet therapy are widely understood and embraced.

Joan Baer and Annie Murphy called it the "power of the paws."

# George C. Ruotolo, Jr., CFRE


George Ruotolo, Jr. has been a leader in fundraising and public relations since 1973.

Before founding Ruotolo Associates in 1979, he served as vice president at a major public

relations and fundraising firm and previously worked in investment banking.

Recognizing the need for a more modern, personalized approach to fundraising consulting, he established Ruotolo Associates with a hallmark commitment to high-level, hands-on professional service.

He brings expertise in pre-campaign studies, annual appeals, capital campaigns, planned giving, and integrated marketing and public relations programs. George has guided successful initiatives for a wide range of organizations—including dioceses, churches, colleges, schools, hospitals, and social service agencies—at the local, regional, and national levels. Throughout his career, he has worked closely with religious, civic, and corporate leaders, as well as administrators, board members, volunteers, and development professionals.



George is Past Chair and a current Trustee of the Ramapo College of New Jersey Board of Trustees and a founding member of the Ridgewood Educational Foundation in Ridgewood, NJ. He also played a key advisory role in Niagara University's capital campaign, which surpassed its \$80 million goal, and has provided counsel to the SUNY New Paltz Foundation. George has shared his insights as a guest lecturer at Baruch College, Columbia University, and Boston University. He has also served as a spokesperson on philanthropic issues for national media outlets, including appearances on CNBC's Money Talk, NPR, CNN, MSNBC's Donahue, and features in Worth Magazine.

A recognized speaker and seminar leader, George has addressed major conferences on topics such as leadership, fundraising, development strategy, and nonprofit communications. Ruotolo Associates is one of the longest standing members of The Giving Institute, the hallmark of ethical fundraising, where George has served as Chair. He is also a board member and former Chair of the Giving USA Foundation, publisher of the Giving USA report.

George is a Certified Fundraising Executive and a member of AFP's New Jersey Chapter. In 2005, he received the chapter's Robert J. Smythe Outstanding Professional Fundraiser Award in recognition of his impact on the field.
