This position involves oversight of individual and corporate gifts as well as planned and capital giving campaigns. If you have a strong background in non-profit fundraising and event management, we encourage you to apply.

This team member must be extremely well-organized and competent in team management. Communication skills and attention to detail are critical and the primary path to success. A passion for outdoor recreation is a must and authenticity in some area of mountain-craft will separate a candidate from other applicants. The CRDO reports directly to the Executive Director and will direct the work of two staff members. The CRDO will also work closely with our Board and, specifically, the Fund Development Committee of the Board.
