National Philanthropy Day Nomination Narrative

Outstanding Professional in Philanthropy - Fundraiser

Nomination for Jan Weimer, Vice President of Development, YMCA of Metropolitan Denver. Nominated by Mike Jackson, Community First Foundation

1. What are the nominee's specific achievements?

Since beginning her career with the YMCA of Metropolitan Denver nearly 40 years ago, **Jan Weimer** has catapulted from an assistant physical director to an instrumental fundraiser and inspiring leader. Among her many achievements, the following illustrates Jan's impact in Denver area communities.

Fifteen years ago the Arvada community was in dire need of full-day childcare and other programs to support the rapidly growing suburb. Community leaders and citizens determined that building a Y was an ideal solution to support the Arvada's robust and projected growth. Jan Weimer was vital in raising \$7.95 million capital campaign to build the facility — the organization's newest, largest and "flagship" branch. Jan also served on the project's design and construction team, coordinating the complex needs among builders, the community and Y headquarters. Much of her success hinged on her talent in engaging the community and building relationships with the West Chamber, Kiwanis Club and City of Arvada to make the project happen.

Named the **Susan M. Duncan Family YMCA**, today the Arvada Y is a vibrant community center serving more than 6,500 people in the areas of youth development, healthy living and social responsibility. Citizens recently voted the site "Best of Arvada" in numerous categories, such as best local nonprofit, best pool, best nursery/day care, and best fitness center—a testament to the success and popularity of the Y and its local impact. Jan's dedication and perseverance were vital to bringing this resource to the community.

Jan Weimer was also integral in launching and sustaining **Janet's Camp**, a highly successful and important annual fundraising event. Janet's Camp attracts community leaders, professional athletes and others to provide financial assistance for low income families to attend a YMCA summer camp.

Together with the support of Janet Elway (former wife of Broncos quarterback John Elway), Janet's Camp has helped more than 3,000 children attend summer camp in the last eight years. These camps give children a safe, secure place, while engaging them in a variety of activities that nurture their spirits, challenge their minds, and strengthen their bodies.

The families who received Janet's Camp scholarships provide testimony to illustrate the value of the incredible opportunity to attend camp:

"The YMCA has provided my children a safe and loving environment to spend their summer vacation. I cannot tell you how much this sponsorship has changed not only my life but my children's. I am grateful to have this kind of support from our community." The Brown family

“My son received a partial scholarship and we couldn’t be happier with his progress. He is suspected to be borderline autistic and the staff at the camp has handled his situation well. The scholarship helped us through some tough financial times.” The Smith family

Jan has overseen this event for the last nine years and has been committed to keeping this unique fundraiser so successful. To date, Janet’s Camp has raised over \$1.1 million.

2. What impact has the nominee had on volunteerism and/or financial contributions and/or the community?

Thanks to the leadership of Jan Weimer, The Denver Metropolitan YMCAs have raised more than \$8 million through their annual campaigns since 2007. These campaigns raise money to offer scholarships and subsidize programs to ensure that our local YMCAs are affordable for all.

Jan spearheads the annual campaigns, coordinating numerous branches and even contributing to statewide efforts. Jan’s ability to educate and inspire staff and volunteers in order to create an army of fundraiser sets her apart as a fundraiser.

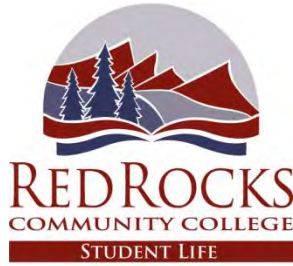
Jan is also leading a \$6 million capital campaign for the expansion of the Schlessman Family YMCA and a new Y in Aurora. The Schlessman facility is a complete remodel designed to foster more family interaction and improve access for seniors. By working with local communities, Jan and other YMCA leaders are able to listen to and understand local needs and design solutions.

In this way, YMCAs become vibrant community centers, providing individuals from all walks of life with a common area in which members can interact with one another while participating in programs and activities that promote healthy spirit, mind and body. As one member explains:

“When we became part of the Denver Y we belonged. The people who are part of our children's lives--people of all ages--including surrogate grandparents-- are always here for them. They've learned to be good sportsmen, good people. So while we are in the gym, our children are not part of a larger family. Just having a 'community' within the community is probably the best thing about being here.”

3. What leadership qualities does the nominee possess that promote philanthropy and/or volunteerism?

Jan Weimer has been with the Y for nearly 40 years--and that says something about her dedication and character. Not only does she help Y members, program participants and volunteers, but she is also dedicated to helping the staff she supervises to learn, grow and thrive. Jan is continually seeking ways to help her staff and their careers. Whether through training opportunities or new job growth, she pushes them outside of their comfort level to be successful. Some of the staff she has mentored have become leaders themselves, serving vital roles as executive directors at the Y. Jan’s personable, passionate, and caring style helps her engage others and garner support for projects that benefit the community. She is always looking ahead to the future and doing all she can to make it better.
