National Philanthropy Day Nomination Narrative Lifetime Achievement Award Nomination for Shari F. Shink, Esq., Founder and CEO of Cobbled Streets. Nominated by Colleen Abdoulah

1. What are the nominee's specific achievements?

For almost four decades, Shari has dedicated her life to transforming the fostercare system and the lives of abused and neglected children around the country. She challenged obstacles, changed laws, and became the inspirational voice for children.

Judge Richard Gabriel writes, "Shari founded the Rocky Mountain Children's Law Center (RMCLC) at a time when thousands of children were in dire need but had no voice. Shari single-handedly gave them a voice, and she has continued to do so over the thirty ensuing years. Through Shari's leadership, the RMCLC's litigation efforts have resulted in some of the most important Colorado legal precedents protecting children. She has also developed and fought for important legislation in this field; she has spearheaded numerous programs to combat child abuse and neglect; she has trained hundreds, if not thousands, of lawyers and law students to advocate on behalf of children; and she has continually shined a spotlight on critical issues, inspiring action at every level of society...it is not an overstatement to say Shari's singular contributions in the field of child advocacy reverberate throughout Colorado and nationally, and I can think of no single person who has made a more significant or enduring impact on behalf of dependent and neglected children in this state."

Over the last 25 years, Shari has been a leader in promoting and testifying on behalf of legislation which includes a speedy trial right for abused children, to prevent languishing in foster care; recognizing that it is in the best interests of children to remain with caregivers with whom they are attached; promoting the importance of maintaining sibling relationships; stopping the arbitrary movement of children from foster home to foster home; expediting permanency planning to assure children a timely permanent home; securing legal standing for foster parents and creating the Office of the Child's Representative (OCR). Twenty-five years ago, Shari won a hard-fought case on the western slope that led to legislative efforts to provide an administrative review system to address the seemingly arbitrary placement decisions that were made in the counties. The statewide ARD (Administrative Review Division) continues to this day.

Shari's extrordinary work led to her induction into the Colorado Women's Hall of Fame in 2013.

After leaving the Law Center as *President Emeritus*, Shari continued to dedicate herself to the needs of Colorado's most vulnerable children. In 2020, she founded Cobbled Streets with a mission to provide enriching opportunities and life changing experiences so kids in foster care develop new skills, create connections, improve relationships, and thrive and give foster parents a new resource when the system said "no". In partnership with local agencies, Cobbled Streets has had a significant impact. Children have experienced nature, sports, music and dance through Equine Therapy, summer camp, golf, violin, hip hop and swim lessons, and more. For many of the children, it has been their first introduction to such things. One foster parent wrote, "The six weeks lessons through Cobbled Streets made a difference with our foster children. It gave a chance for them to connect, learn life skills, and allowed them to put their problems aside. They were able to celebrate accomplishments and overcome obstacles in a positive way. Most of all they were able to create healthy relationships. It gave them something to look forward and building blocks to start to trust others. It sparked endless possibilities and encouraged them to dream."

In addition, Shari Shink and Cobbled Streets are in the midst of producing a documentary on the Foster Care System which will be used to spark systemic reform nationwide. The film is due to be released in late 2023 or early 2024.

2. What impact has the nominee had on volunteerism and/or financial contributions and/to the community?

Shari's passion, enthusiasm, and persistence impacts everyone with whom she comes in contact. Her genuineness and authenticity, her unwavering commitment to children, and her courageous leadership, have inspired so many. In her decades at the helm of the Rocky Mountain Children's Law Center, she inspired philanthropists of all ages and all means. Her first donation came after a speech in Chicago when her 5 year old nephew donated the only dollar in his pocket! Her largest donation came years later as an anonymous gift of one million dollars.

When Shari created the Rocky Mountain Children's Law Center, she developed the Domestic Violence Program. Recruiting, training and coordinating a small army of volunteer attorneys to represent hundreds of abused children in Colorado every year for over 30years.

At Cobbled Streets, Shari has a following of dedicated donors who respect the work she has done and the person she is. Shari has received financial support from friends, collegues, and donors from California, Illinois, Michigan, Wisconsin, Pennsylvania, Florida, New York, Tennesee, and even Italy and Germany. As a new organization, Cobbled Streets relies on an enthusiastic group of volunteers and philantropists who know, without doubt, that through their contributions they will change the lives of children in Colorado. In the two and a half years Cobbled Streets has existed, Shari has raised over a million dollars from about 200 diffferent donors.

3. What leadership qualities does the noiminee possess that promote philanthrophy and/or volunteerism?

Shari's passion to help foster children is infectious. She is able to inspire enthusiasm, creativity, and hard work. Her compassion builds trust; her relentless quest for good inspires hope; and her support encourages everyone to be their best.

4. How does the nominee adopt a spirit of inclusion?

Shari is committed to seeking the voices of those who are held in high esteem, as well as those who believe they have no voice. As a new organization, diversitiy continues to be a priority in seeking new board members and new staff. The work of Cobbled Streets brings together children and families whose cultural, economic, and life experiences are different. These opportunities have enriched the experiences they share with their children and serve as a foundation for a better, more inclusive world.

There was a buzz of excitement in the room normally reserved for the elected officials. But at this panel, the buzz was due to Shari Shink attending.

After she formed Cobbled Streets, Shari reached out to me to partner and serve families together. I could not have been more thrilled. Her work at Cobbled Streets provides opportunities for normalcy for children experiencing child welfare. Our work at Foster Source serves the caregiver. Together, we are empowering families to access services and resources they need to thrive. Shari and I have always had a shared vision of support for families that left them feeling less dependent on the "system" and more empowered as a family unit.

During our work together, we often pass family requests that are outside Foster Source's scope to Shari and her team at Cobbled Streets. Shari's infectious generosity is unmatched. When you need something to happen that seems impossible, call Shari. When you feel like you're emptying the ocean with an eye dropper and you're questioning whether you're making a difference, call Shari. When we had a fresh food donation that we didn't think we could take due to a lack of large refrigeration capabilities, we called Shari, and she gained access to refrigeration within 20 minutes. When we had a family with 8 children who needed a vehicle to transport the family of 10, Shari had an affordable option within a week.

A friend like Shari Shink is rare. Generosity like Shari's is even more rare. She is deserving of any and all accolades. I will always stand behind her with a smile on my face and a willing spirit ready to absorb her sunshine and warmth.
