## **AIPLA Event Updates:**

- AIPLA IP Practice in Europe Committee Trip Summary-Kathleen Lemieux On June 3, 2019, the IP Practice in Europe Committee began its week-long trip in three European cities, beginning with London, followed by Paris and ending with Munich. The trip began with a sunny and warm day in London, where we met with CIPA and FICPI-UK, ending the day with AIPPI-UK. As always, participants were enthusiastic about our meetings and delegates of all organizations were able to exchange views on various topics. The day was punctuated with a Diversity lunch discussing the business case for diversity. Our delegation then may the journey to Paris by train – to meet with AIPPI-France and ASPI, a French organization serving those who 'specialize' in industrial property services (Association Française des Specialistes en Propriete Industrielle de l'industrie). Our time in Paris was very short – almost too short – however, our hosts were very gracious and presentations exchanged on the part of all three organizations were very interesting. We ended our trip in Munich (for two days), where we met with GRUR and AIPPI-Germany, where we learned about the EPO's recent position on simulations as computer implemented inventions. Those meetings were followed by presentations and dinner with EPLAW. On Thursday, we met with representatives from the European Patent Office and the Board of Appeals in the earlier part of the day, followed by meetings with Patentanwaltskammer. All were in agreement that more interactive discussions would be more interesting than presentations. We will be reconsidering the format of some of our meetings for subsequent trips. As always, we ended with our traditional 'farewell' dinner on Thursday evening. All in all, it was a fantastic week!
- AIPLA IP Practice in the Far East Trip Summary-Tiep Nguyen The IP Practice in the Far East Committee went on their trip from April 29 to May 3, 2019. They visited Taiwan and Singapore. They toured the Taiwan IP Court, including the courtroom, on April 29th. That afternoon they visited the Taiwan Intellectual Property Office (TIPO). The following day, the AIPLA delegation visited the Taiwan Ministry of Justice Investigation Bureau and met with the Taiwan Patent Attorneys Association.



On May 2, the AIPLA delegation visited Singapore and met with the Association of Singapore Patent Attorneys and its Executive Committee. On May 3, the AIPLA delegation met with the Singapore Group of Asian Patent Attorneys and with IPOS.



- APEC IPEG Roundtable on Patent Grace Period AIPLA participated in the Grace Period Roundtable panel sessions organized by the USPTO at the Asia Pacific Economic Cooperation (APEC) International Patent Experts Group (IPEG) meetings held in Santiago, Chile on February 26th. The panels included representatives from USPTO, JPO, IP Australia, Department of IP-Thailand, Chinese Taipei, FICPI and AIPLA.
