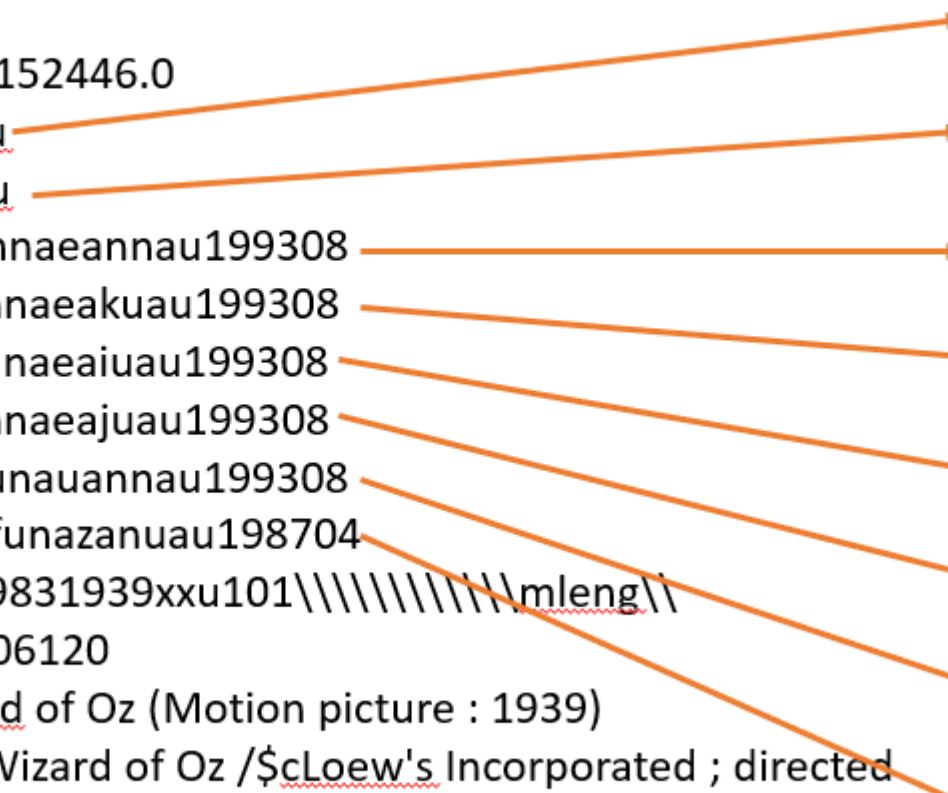

# The influence of MARC

- The Library has a requirement to distribute MARC records
- Many recent data conversion decisions have been driven by the BIBFRAME to MARC transformation
  - Addition of bf:status to provision activity data for serials records
    - If bf:status="current", create 26X Ind1=# or 3
    - If bf:status="earliest", create 26X Ind1=#
  - Addition of bf:status to classification numbers
    - If bf:status="used by agency", create 050 Ind1=0
    - If bf:status="not used by agency", create 050 Ind1=1
  - Splitting MARC records based on data in 007, 300 and 856 fields

# One MARC record $\neq$ One resource

- Solution? Create many MARC records, then pass them through marc2bibframe conversion program
  - The new Preprocess 0 addresses the treatment of a MARC record *before* it is converted to BIBFRAME
  - MARC 758 field provides a link between the newly-created MARC records
  - The marc2bibframe software creates one work with multiple instances
- bibframe2marc
  - Re-combines the multiple BIBFRAME instances into a single MARC record with paired 007/300 fields

# Follow LC-PCC PS for RDA 3.1.4 and create multiple 300 fields to match multiple 007 fields

## Accompanying Material

*LC practice/PCC practice:* When describing the carriers of accompanying material, follow one of the approaches outlined below. Apply these guidelines even when the accompanying material is of the same carrier type as the main part.

1. If a detailed description of the carrier characteristics of the accompanying material is desired, record the extent (see [RDA 3.4 RDA](#)), and other characteristics applicable to the accompanying material (see [RDA 3.5 RDA](#)–[3.19 RDA](#)). Provide this information as either:
  - a) a separate additional MARC field **300**  in the bibliographic record

### EXAMPLE

**300 ##**     \$a [carrier information for main part]

**300 ##**     \$a 1 map : \$b color ; \$c 25 x 35 cm
