## Policy

Use the procedures below for original and derived cataloging of streaming video.



## Reason for Policy

This document is based largely on OLAC's *Best Practices for Cataloging Streaming Media Using RDA and MARC21* (Version 1.2, September 2022) and records local UI decisions concerning these materials.

## Provider Neutral Records

The University of Iowa Libraries facilitates the use of provider-neutral records for streaming videos within WorldCat and other shared cataloging repositories for the benefit of all libraries who use these repositories.

However, some features of streaming materials within the University of Iowa Libraries will be specific to the item within the collection so to increase access for users.

When a streaming video record is needed, the record should be cataloged in WorldCat as provider neutral. After the record is imported in Alma, necessary additions may be made to the record so that it is specific to the provider.

Note that in WorldCat, there should be a separate record for every accessibility/language variation of the same video. For example, if a video can be found on one platform with subtitles in a different language and the same video doesn't have subtitles on another platform, then two separate records would be warranted. Additionally, if there was another version of the video that existed with open captions, then that would also have its own record.

## 01X-09X fields

### 046 / Original release date

LOCAL UI POLICY: as an extension of RDA 2.17.6, make a note about the place and year of the original production and/or release when this information is available. This provides an eye-readable note for users, as fields 257 and 046 \$k may not display.

Record the original release date in MARC 046 \$k (Special coded dates / Beginning or single date created). For field 046, use EDTF schema (YYYY, YYYY-MM, OR YYYY-MM-DD with \$2 edtf).

### 033, 518 / Place and Date of Capture

Record information about the recording, filming, or broadcasting of a resource (an aspect of the history of the work). If place and date of capture is readily available from the video or on the platform's website, record as a formatted textual statement in field 518 and in coded form in field 033.

## 1XX fields

### 130, 240 / Preferred title

LOCAL UI POLICY: when constructing access points for motion pictures and television programs, follow RDA and LC-PCC PS 6.27.1.9 Appendix 1 (available via the RDA Toolkit; provisional as of 2017-11).





Following OLAC best practices, base the title on the form appearing in a title screen in the original language whenever possible.

A preferred title (uniform title) is needed especially in the following situations:

- Title of resource conflicts with the title of another resource
- Films issued with different titles in the same language
- Dubbed versions
- Motion picture released under the same or different title

For motion pictures, a preferred title (uniform title) in MARC field 130 may be necessary for a resource which contains a single film. Use MARC field 240 for a preferred title **only** when field 100 is present for a filmmaker (an individual responsible for all aspects of a film).

If there is a single film that is dubbed, use a 130 and put the name of the language into which it is dubbed in \$l. If there is more than one language version of the video on the resource, use 730 instead.

Examples:

LOCAL UI POLICY: For television programs, add a preferred title to **all** bib records (using MARC field 130 for resources with single titles).

Examples:

Resources with multiple films or television programs (such as compilations) or resources containing more than one language version of the video will have all preferred titles in 730 fields. See the section below on access points for analytical titles.

Check to see if there is a conflict (see steps below for procedure), and if there is a conflict:

- Add the form of work to the heading in parentheses. Use (Motion picture) for those distributed theatrically, non-theatrically, or as home video. Use (Television program) for those that originally aired on TV (regardless of subsequent home releases)
- In case of doubt, use (Motion picture)
- If it still conflicts, add in this order:
  - Year of original release (or year of original production)
  - Director or filmmaker (give name in shortest intelligible form)
  - Production company (in NAF form)

[LC-PCC PS 6.27.1.9 Appendix 1; RDA 6.4]

**To determine the form of the preferred title, follow these steps:**

## 1. Search NAF

- If there is a preferred title in NAF for the motion picture or television program being cataloged, add it as a 130 (or 730 if more than one film contained in the resource)
- Make sure that the title in question is for the same motion picture. If the preferred title is for a different motion picture, create a new NAR for the item being cataloged and revise the existing NAR to include the year of production. [If you don't have NACO status, include a preferred title without conflicts in the bib record for the item in hand.]

*Example: item in hand is 1921 motion picture, Four horsemen of the Apocalypse*

130 0\_ \$a Four horsemen of the Apocalypse

*Existing NAR for the 1962 motion picture*

130 0\_ \$a Four horsemen of the Apocalypse (Motion picture : 1921)

*New NAR for the item being cataloged*

130 0\_ \$a Four horsemen of the Apocalypse (Motion picture : 1962)

*Revision to existing NAR*

- If the year would fail to distinguish the work being cataloged, see above for other possible additions to the qualifier

*Example:*

130 0\_ \$a Harlow (Motion picture : 1965 : Douglas)

*Preferred titles from two bib records*

## 2. Search WorldCat

- Search to see if there is another work entered under the same title as the work being cataloged (fields 130, 245 \$a when there is no 1XX, 490, 730, 740, 830)
- If such a record is found, create a preferred title for the item being cataloged, using the appropriate qualifier

### 3. Search Internet Movie Database (IMDb)

- Search to determine whether there is more than one motion picture or television program of the same title. Ignore initial articles.
- If there is a conflict between a motion picture and a television program, use the qualifier (Motion picture) or (Television program)
- If the conflict is between two or more motion pictures or two or more television programs, add the date of release/first telecast. If that fails to distinguish, see above for other possible additions to the qualifier.

## 20X-24X fields

### 245 / Title (MARC 245)

Transcribe the title as it appears on the source of information. Under RDA, for a video consisting of a single work or a single predominant work with ancillary works, the order of preference for the source of info is:

1. Title screen
2. The video's landing page on the platform where it's located
3. External source on another website

If the title comes from anywhere other than the title screen, add a 500 note explaining the source of the title.

The first indicator is always 0 if there is no 100 field (and 1 if there is).

### 245 \$c / Statement of Responsibility

LOCAL UI POLICY: generally record work-level roles in the statement of responsibility (creators of the intellectual or artistic content such as screenwriters, filmmakers, directors, directors of photography, producers, and production companies). Feel free to also include, on a case-by-case basis, others whose status as a creator is obvious given the nature of the work being cataloged (e.g. choreographer for a ballet film, editor for a film consisting of edited found footage, animator of an animated films, etc.).

Other technical credits should go in field 508 if considered important; cast should go in field 511.

Statements of responsibility are transcribed as shown on the source of information, which could be the same source as the title proper or another source within the resource (e.g. landing page). If statements of responsibility are not on the item but are taken from an outside source (e.g. a website), put them in brackets (RDA 2.2.4).

# IOWA

Record multiple statements of responsibility in the order indicated by the sequence, layout, or typography of the source of information. If the order can't be determined, record in the order that makes the most sense.

When deriving a record from an existing record, do not re-do the statement of responsibility unless it is inaccurate.

Examples:

245 00 \$a Burt's buzz / \$c Everyday Pictures presents in association with Buffalo Gal Pictures ; produced and directed by Jody Shapiro.

245 00 \$a Sense & sensibility / \$c by Jane Austen ; screenplay by Andrew Davies ; produced by Anne Pivcevic ; directed by John Alexander ; BBC, WGBH Boston co-production.

130 0\_ \$a Sherlock (Television program : 2010- ). \$n Season 3.

245 10 \$a Sherlock. \$n Season three / \$c a Hartswood Films production for BBC Wales in co-production with Masterpiece ; co-created by Mark Gatiss & Steven Moffat ; written by Mark Gatiss, Steven Moffat and Steve Thompson.

## 246 / Variant Titles

Record variant titles that are important for identification or access. These may include:

- Titles that appear on the resource itself (title screens, landing page)
- Titles from reference sources (e.g. IMDb)
- Corrections to titles
- Part of a title recorded as part of the title proper (e.g. section title)

Optionally, indicate where the variant title is coming from in \$i:

Also known as:

Title on English subtitles:

Title appears in credits as:

Etc.

Indicators:

Encode most variant titles in field 246. Record individual titles in a collection in field 730. Use field 740 for title access points when an authorized access point is not needed (e.g. titles of significant accompanying booklets).

## 25X-28X fields

### 250 / Edition Statement

This attribute is not provider neutral. Do not include this information when cataloging a record in WorldCat. If the streaming material has an edition statement, add the statement after importing the record into Alma.

Transcribe the edition statement. Do not use abbreviations unless present on the resource. If in doubt whether a statement is an edition or printing statement, look for the following:

- Words like edition, issue, release, level, state, or update (or their equivalents in another language)
- A statement indicating a difference in content, geographic coverage, language, audience, format or physical presentation, or date

Record aspect ratio as an edition statement only when the word edition (version, etc.) is present on the resource. (In that case, record both as an edition statement and as a note). Otherwise, record aspect ratio separately as a note in field 500. Do not include a numerical aspect ratio as part of an edition statement in MARC 250.

Examples:

250 \_\_ \$a Director's cut.

250 \_\_ \$a 20<sup>th</sup> Anniversary edition.

250 \_\_ \$a Remastered deluxe edition.

250 \_\_ \$a Deluxe Blu-ray edition.

250 \_\_ \$a Newly restored ed.

250 \_\_ \$a Special widescreen edition.

500 \_\_ \$a Wide screen (1.78:1).

The word "edition" is present on the resource

### 257 / Country of the Producing Entity

For all videos, include field 257 for the country where the work was originally produced (including U.S. productions). Use the form of the name of the country found in the LC/NACO authority file.

Base the country of the producing entity on the location of the principal offices of the production company or individual by whom the moving image work was made. If this is not recorded in the statement of responsibility, use the best information available.

Each work in a resource receives a separate field 257.

Examples:

## **264 \_1 \$a, \$b / Place of Publication : Publisher**

Determining the publisher of a streaming video can be challenging, as the resource may list many corporate bodies including production companies (who acquire content, organize/manage production, and perform the final editorial review), financing companies (studios and other investors), and distributors.

Distinguishing between publisher and distributor is also challenging. If in doubt whether an entity is a publisher (264 \_1) or distributor (264 \_2), treat as a publisher. It is also common to come across records in WorldCat where the provider is listed as the publisher. This is both inaccurate and not provider neutral. These records should be updated with the appropriate publisher.

To determine the publisher, look for a name or logo before the title credits. The distributor's name will usually appear first and then the production company's name. If it doesn't appear before the title credits, it may also appear during the title credits or during the end credits. Double check whether a company is a production company or distributor by searching them online and see which label is associated with the company. You can even cross reference by looking at a production company's website and seeing if the title that you're cataloging appears there.

When there is more than one publisher, only include the first unless it would be misleading to stand alone. If there is no publication information stated, always try to infer it (e.g. search the web to find the location of the publisher and put in brackets).

Transcribe places of publication and publishers' names in the form in which they appear on the source of information, applying capitalization from RDA Appendix A (old AACR2 capitalization). If the place of publication cannot be found in the source of information, use the location of the production company's offices, which can often be found on the production company's website.



#### Examples:

264 \_1 \$a New York : \$b Icarus Films

264 \_1 \$a [United States] : \$b Milestone Film & Video

The distributor is not a provider neutral attribute. Do not include when cataloging for WorldCat. It is also not necessary to add this information in after importing to Alma.

### 264 \_1 \$c / Date of Publication

For streaming materials, the date of publication should be the date of production for the original film or television production. Record the date of publication as stated in the opening or closing credits. If dates are in Roman numerals, convert to Arabic numerals. If the date of publication is not identified in the resource, supply the date or approximate date of publication in square brackets (RDA 1.9.2).

If no date of publication is given on the resource:

1. If a copyright date associated with the program content or bonus features is present, record the copyright date in 264 \_4 \$c and enclose in square brackets in 264 \_1 \$c
2. Supply a probable date of publication (instead of using “date of publication not identified”)

### 264 \_4 \$c / Copyright Date

LOCAL UI POLICY: Optionally, record a copyright date even if a publication date is present on the resource. When multiple copyright dates apply to the same aspect of the resource, record only the latest copyright date.

## 3XX fields

### 300 / Physical Description

Record the number of items, duration, sound, color, and dimensions.

## 4XX Fields

This attribute is not provider neutral. Do not include this information when cataloging a record in WorldCat. If the streaming material is a part of a series, add the series statement after importing the record into Alma.

If present, series information is usually found on the platform's page where the video is located. Record series statements in field 490 plus an access point in the appropriate 80X-83X field.



Series information for video recordings refers to a publisher series, not a television series.

### 532, 341 / Accessibility Information

In WorldCat, there should be a separate record for every accessibility/language variation of the same video. For example, if a video can be found on one platform with available closed captioning and the same video doesn't have closed captioning on another platform, then two separate records would be warranted. Additionally, if there was another version of the video that existed with subtitles in a different language, then that would also have its own record.

Note accessibility information or features designed for the hearing or visually impaired. Modes of access are described in the 341, and additional details are provided in the 532. Some of the information in the 532 may also overlap with information in the 546 field (language note) and should always pair with the applicable LCGFT in field 655.

Accessibility content includes a translation of the dialog **plus** contextual information such as descriptions of sound effects, musical notes when there is music, or any other sounds that would be missed by someone who cannot hear the audio or see the video. Accessibility is made possible through audio description, captioning, sign language, and/or subtitles.

Closed captions are not visible unless the viewer activates them (Look for a "CC" symbol in the bottom right corner when playing the video). Open captions are always visible.

SDH (Subtitles for the Deaf and Hard-of-Hearing) are subtitles where speaker identification and other non-dialog audio has been added.

Audio description (or Descriptive Video Captioning / DVC) provides a verbal description of the action onscreen for the visually impaired.

It should only be included for digital preservation projects such as the DLF Registry of Digital Masters or the HathiTrust Digital Library. More information can be found on page 77 of the OLAC Best Practices for Cataloging Streaming Media

### 546, 041 / Language of the content

Record coded language data for the content in MARC 008/lang and 041, and free-text language notes in MARC 546:

- Spoken, sung, or signed language of the primary content (MARC 008/lang, 041 \$a, 546)
- Written language of the primary content, including subtitles, captions, intertitles (MARC 041 \$j, 546)

- Subtitles provide a translation of the soundtrack for non-native language speakers. Subtitles assume the listener can hear the audio, and thus include only a translation of the dialog or phrases summarizing the dialog.
- Captions are similar to subtitles but also include contextual information for those who cannot hear the soundtrack. Examples: “[people laughing]” or “[doorbell rings]”
- Intertitles are used in silent films as pieces of text that are inserted into or between scenes of a motion picture. They often convey dialogue or other contextual information.
- Original language of the primary content (MARC 041 \$h)
- Languages of any accompanying material (MARC 041 \$g, 546)
- Original language of any accompanying material (MARC 041 \$m)

In MARC 041, generally encode language only for the primary content. Exceptions: languages of significant accompanying material and librettos. The language of the following items should not be recorded in MARC 041, but can be noted in field 546:

Special feature language information (supplementary content such as audio commentary tracks, spoken and written languages on special features)

Do not use for cast members; use MARC 511 instead.

If you also include an authorized access point for these contributors (7XX), use a relationship designator from RDA Appendix I.

Examples:

## 500 / History of the Work

Provide notes relating to the history of the film, including dates for the original production, regardless of format.

## 500 / Related Work/Expression/Manifestation

Make a note if the video is based on another work. This note is not required, but always include the related work added entry if appropriate (in 7XX).

*Examples:*

500 \_\_ \$a Based on: Siddhartha / Herman Hesse.

500 \_\_ \$a Based on characters created by Arthur Conan Doyle.

500 \_\_ \$a Prequel to the film "Monsters, Inc." (2001).

500 \_\_ \$a Based on Shakespeare's Romeo and Juliet.

700 1\_ \$i Motion picture adaptation of (work): \$a Shakespeare, William, \$d 1564-1616. \$t Romeo and Juliet.

### **586 / Awards**

Include information about formal awards if readily available (on the resource). Record multiple awards in separate MARC 586 fields.

*Examples:*

586 \_\_ \$a Winner, Academy Awards (1977) for best actor in a supporting role ; best sound.

### **500 / Supplementary Content/Special Features**

Include here special features paired with the video on the platform's website that are not recorded as part of the title statement (MARC 245) or contents note (MARC 505). This is not provider neutral and should be added after importing to Alma. Do not note scene selection, advertisements, previews/trailers, deleted scenes, or outtakes.

*Examples:*

500 \_\_ Bonus clips: Ioway Artifacts; Ioway-Otoe Trade; Birthing Cave; Oneoto Artifacts; NAGPRA; Keyes, Orr & Wedel; The Map; Site Preservation; Pumpkin Seeds; and The Mounds

### **Intended Audience (MARC 521)**

Optionally, record intended audience information when it is considered important for identification or selection and available on the item. If the resource is a feature film intended for children, code in the fixed field 008/22 (Audn) and optionally add a note in field 521. If possible, record the information using the wording found on the source.

First indicator 8 = No display constant generated

*Examples:*

521 8\_ \$a MPAA rating: PG; for some mild action and rude humor.

008/22 (Audn) = j

*For an animated children's film*

### **520 / Summarization of the Content**

Provide a summary of content whenever possible. Aim for concise, objective, specific terms that aid keyword searching. Summaries do not need to be written in complete sentences.

If the summary is copied verbatim from the platform website or an external source, enclose it in quotation marks and attribute the source.

*Examples:*

520 \_\_ \$a Discusses the logging vs. environmental battle over the forest lands in the Pacific Northwest. Looks at the sociological impact on the families and communities involved in the logging industry.

## 505, 730 / Contents Note

Provide a contents note for compilations whenever feasible (generally following instructions in LC-PCC PS 25.1 and LC-PCC PS 25.1.1.3).

In addition to the contents note, include a title access point for each work contained in the resource.  
[730 ... \$i Container of (work): ]

When there are multiple sets of credits, use judgment to choose between including the credits in the contents note or in separate MARC 511, 508, and/or 500 fields.

*Example:*

245 0 0 \$a Essential Eastwood : \$b director’s collection / \$c directed by Clint Eastwood.

505 0\_ \$a Letters from Iwo Jima – Million dollar baby – Mystic river – Unforgiven.

730 02 \$i Container of (work): \$a Letters from Iwo Jima (Motion picture).

## 506 / Restrictions on Access

When applicable, note any specific limitations on access to a resource. This is not provider neutral and should be added after importing to Alma.

First indicator:

Blank = no information provided

0 = no access restrictions

1 = restrictions apply

506 1\_ \$a Restricted to individual viewing only at the University of Iowa Hardin Library for the Health Sciences.

506 \_\_ \$a Film available for viewing after 2020.

## 6XX fields

### 600, 610, 611, 630, 650 / Subjects

Assign, as appropriate, subject headings for the topic of the film. Most moving image records will include access by subject.

# IOWA

*Fiction films:* As with works of literature, not all films have a “topic” and so may not have a subject heading. If possible, however, assign at least one subject heading. The form subdivision \$v Drama” is usually appropriate for fiction films.

*Examples:*

## 655 / Genre/Form

All records for videos should include access by genre/form. UI generally follows the OLAC best practices document for LCGFT. Library of Congress Genre/Form Terms (lcgft) may be browsed in ClassWeb (under genre/form terms) or in Connexion (under the genre headings “motion pictures” or “television programs” with retrieval of a list of 555 fields).

Unless noted as local, terms below are from LCGFT and coded 655 \_7 \$a [term] \$2 lcgft

Code local terms as 655 \_7 \$a [term] \$2 local (in Alma only; do not add to master records in WorldCat Connexion)

**655A.** *Fiction or nonfiction.* If possible, assign one of the following terms:

- Fiction films
- Nonfiction films
- Fiction television programs
- Nonfiction television programs

**655B.** *Duration.* Assign one of the following terms to both fiction and nonfiction films that have been or were originally intended to be exhibited theatrically or otherwise shown publicly, such as at a film festival. Do not use with educational films or videos made for classroom use or for instructional videos

- Feature films [running time ≥ 40 minutes]
- Short films [running time < 40 minutes]

**655C.** *Accessibility.* Assign, if appropriate, one of the following terms:

# IOWA

- Video recordings for the hearing impaired  
*Include captions or sign language specifically as an aid for the hearing impaired*
- Video recordings for people with visual disabilities  
*Include additional audio description provided for people with visual disabilities*

LOCAL UI POLICY: use the LCGFT “Video recordings for the hearing impaired” as opposed to “Films for the hearing impaired” or “Television programs for the hearing impaired.” (And the same for “Video recordings for people with visual disabilities.”) If the WorldCat copy has “Films for...” or “Television programs for...” do not change the master record in WorldCat. Instead, edit the record locally in Alma.

**655D.** *Basic broader terms.* Whenever applicable, assign one or more of the following:

- Children’s films
- Children’s television programs
- Documentary films
- Documentary television programs
- Made-for-TV movies
- Silent films

**655E.** *Narrower terms.* As appropriate, assign one or more narrower genre terms from LCGFT. Do not subdivide narrower terms.

*Examples:*

Animated films / Animated television programs  
Comedy films  
Biographical films  
War films  
Historical films

**655F.** *Access to the language of the resource* [LOCAL UI POLICY/in Alma only]. For non-English language resources, assign at least one term for the original sound track(s) in the form “...language films” or “...language television programs”. Also apply this policy to musical films with a discernable language, e.g. an opera sung in Italian. Generally do not assign this type of term to English-language films. Code as local terms.

*Examples:*

For videos produced by non-U.S. film production companies, assign at least one term for the primary country of the film production company in the form “Motion pictures \$z [country].” This is the country where the company has its principal offices, or in the absence of a company, where the individual producer of the resource is located. The country/countries in this field 655 match field 257. Code as local terms.

Examples:

Use Great Britain for English production companies:

Do not use the terms “Motion pictures” or “Television programs” alone without subdivision.

## 700, 710 / Access Points for Persons and Corporate Bodies

Provide access points for:

- Creators such as screenwriters, filmmakers (generally makers of small indie films who are usually the producer, director, writer, and cinematographer), or interviewers and interviewees (if the film is primarily an interview)
- Directors of feature films
- Prominent performers (e.g. actor, voice actor, singer, conductor, dancer)
- Other persons associated with the work or expression (e.g. animator, composer, director of photography, costume designer, choreographer)
- Production companies
- Other corporate bodies involved in the making of a film or TV program (especially when prominently named on the piece and deemed likely to be a useful access point)

# IOWA

Use a relationship designator (\$e) from RDA Appendix I that describes the relationship of the person/corporate body to the resource. If there are multiple applicable terms, put them in repeated \$e in WEMI order. If the relationship can't be determined, omit \$e.

After the record has been added to Alma, add another 710 field for the platform using \$e Provider.

## Examples:

### 700, 730, 740 / Access Points for Analytical titles

Include access points for whole-part relationships (component works within a resource such as multiple works on one link, significant separately titled accompanying works) and multiple language expressions.

Second indicator =2

Except for 740s, precede the title with \$i Container of (work): or \$i Container of (expression):

If the link has multiple works and a collective title, also check the collective title for conflicts as well as the individual film titles. If the collective title needs a qualifier, use one or more of the following (whichever makes the most sense in the circumstance): corporate body, date of publication, descriptive data elements (e.g. edition statement), place of publication.

Include access points for derivative or sequential work relationships, especially related work added entries for adaptations of literary or dramatic works. Use relationship designators (\$i) from RDA Appendix J.

### 856 / Electronic Location and Access

WorldCat policy allows for an 856 field for every platform where the video may be found. If the provider's video link is not included in the record, you may add it, but add the universal link and not the link with the library's proxy.

### *Example:*

856 40 \$u <https://www.kanopy.com/en/video/69785>

NOT 856 40 \$u <https://www.kanopy.com/en/iowa/video/69785>

After importing the record into Alma, delete all of the 856 fields except for the platform where the video can be found in the catalog.
