Steering Committee Updates

1. An ALA executive board update was shared on ALA Connect. (Sara)
2. [Website update](#) (Christina)
3. Round Table Coordinating Assembly [update](#) (Lisa)
 - a. Lisa attended meetings for Process and Dues recently. The goal is to simplify the membership model.
 - b. No changes will begin until Sept. 1, 2023 and first the membership must vote on the changes.
 - c. They provided scenarios and asked assembly members to rank each option. Lisa ranked according to preference those scenarios which kept student membership free or low-cost, as student membership is free in our current model.
 - d. In addition to standardizing many of the membership fees, protections have been proposed for roundtables that may be impacted.
 - e. Questions and Comments:
 - i. "What comes next?" The survey results will be shared and hopefully we will have a majority to move forward with the proposals for the membership.
 - ii. "Is this a permanent assembly?" I believe this is a task force.
 - iii. I think the RT Coordinating Assembly predated this process.
 - iv. "I hope they can go with free student memberships! Seems like a long shot, but I think it would be a good idea in the long run."
4. [Bylaws update](#) (Lisa)
 - a. The template for bylaws is not mandated but it is encouraged.
 - b. The only changes being requested to our bylaws are those needed to be consistent with the requirements from ALA.
 - c. Mat Bollerman, Casey Conlin, and Lisa Kropp were on the bylaws taskforce this past year and focused on incorporating the triple bottom line into the bylaws.

- d. They also decided to remove the language for free student membership since it is unlikely student membership will remain free after 2023.
 - e. Changes to bylaws: Steering Committee approves changes by Nov., changes are then sent to Danielle to be included on the spring member's ballot.
 - f. Bylaws are also included in the procedures manual.

 - b. Jen F. - We should be able to pay for speakers, as in an honorarium. We just need to decide on a budget. Last year we also found co-sponsors for programs.
 - c. Mandi G. - Didn't we bring Bill McKibben one time? I wonder if he charged a fee?

Tina - I will look at past speaker fees.

 - a. We will have someone from their table attend our meeting and other Round Table's meetings.
