Report from the Treasurer

Thank you to all our members for your support! Membership dues are still \$8 a year and free for students – ASA members can also try sections out for free for a year.

Our finances for last year and this coming year are starting to look more like pre-pandemic years, primarily driven by JSM returning to an in-person format.

A high-level summary of the last calendar year (2022) includes:

- Income (~\$6,300), primarily from:
 - Membership dues (~\$4,700)
 - Webinar registration fees (~\$1,400)
- Expenses (~\$17,000), primarily from:
 - JSM SRMS Mixer (~\$6,500)
 - Big Surv Sponsorship (\$6,000)
 - JSM 2022 Student Paper and Travel Awards (\$3,825)

Despite our expenses being larger than our income in 2022, our finances are still in great shape. As of May 31, 2023, we have an account balance of approximately \$35,000, which is roughly twice our 2022 expenses. Importantly, expenses such as the Big Surv sponsorship frequently turn into revenue, as the section will share in any profits. Additionally, a deal has been reached with the publisher of JSSAM that includes free access for all SRMS members *without any additional cost to SRMS*! So that expense of ~\$3,000 per year – which we have been incurring since that journal started – will no longer be on our books.

Of course, we are always on the lookout for additional revenue opportunities or reduction in expenses. We are working to offer more webinars and continue to invest in conferences in an effort to maintain these important sources of income. We also welcome ideas for sponsorship and educational opportunities to benefit our members!

Each year SRMS gives awards to students to cover part of the costs of attending JSM. Applicants submit a short essay, a letter of recommendation from a faculty member, and college transcripts. A panel appointed by the SRMS Executive Committee selects the awardee(s) based on the submitted materials. The 2023 panel consisted of Brady West (SRMS Chair) and myself.

The recipient of the JSM 2023 SRMS Student Travel Award is **Chengpeng Zeng, Iowa State University, Department of Statistics**. Congratulations to Chengpeng!

SRMS is committed to providing a financial award to allow deserving students to travel to the JSM. We look forward to awarding student travel funding for the 2024 JSM in Portland, Oregon (August 3-8, 2024). Unfortunately, we have seen a decline in applications in recent years – if you are an SRMS member who knows of deserving students, please encourage them to apply! The application will be available in October 2023 (on the [SRMS website](#)).

Historically, applications for the travel award were due in mid-December. Since students may not decide whether they will attend the JSM until closer to the JSM abstract submission deadline (usually in early February), the SRMS Executive Committee has decided to extend the **application deadline for the 2024 Student Travel Awards to January 15, 2024**.
