

GSS Award Competitions – Approaching Deadlines

Data Expo 2019

GSS is excited to host an annual Data Challenge Expo to be jointly sponsored by three ASA Sections – Statistical Computing, Statistical Graphics, and Government Statistics. The Data Challenge Expo is open to anyone who is interested in participating. This includes government, industry, academia, retirees, and students. There are two main categories of participants: Students/Educational and Professionals. Winners will be recognized at JSM.



The data set for the 2019 data challenge is the New York City Housing and Vacancy Survey (NYCHVS). The NYCHVS is a representative survey of the New York City housing stock and population sponsored by the New York City Department of Housing Preservation and Development (HPD). It is the longest running housing survey in the country.

Research questions include consideration of the importance of housing quality and conditions and how they have shifted over time, possible impacts of new rent control measures as well as the costs and benefits of renting versus owning, creation of a gentrification measure, and describing changes in housing conditions for second generational immigrant households.

Wray Jackson Smith Scholarship – April 1

Awarded jointly with the ASA's Social Statistics Section, this scholarship supports work toward a career in government statistics. The scholarship encourages promising young statisticians to consider a future in government statistics by providing up to \$1,000 for use in exploring any of a broad number of opportunities. The Wray Jackson Smith Scholarship (WJSS) was created to honor the memory of a founding member of the Government Statistics Section and a longtime contributor to federal statistics.

This scholarship is for students and others early in their careers who show an interest in government statistics. Applications will be evaluated on relevance of the proposed activity to government statistics, quality of the proposed activity, innovation/ingenuity of the proposed project, feasibility of completion of the activity, the applicant's career stage, and past performance as reflected in the letters of recommendation.
