Topic : "Econometrics and the Law: The Case of the Missing Tomatoes"

For plaintiff's counsel in antitrust litigation, an econometric analysis may seem quite attractive. Here is scientific, objective proof of market power and damages--backed by the prestige of mathematics, economics, and the computer. However, defense counsel need not despair. On closer examination, the econometric analysis may turn out to be no more than a series of unsupported assumptions, even if these are expressed as formidable equations.

AMENDMENT TO BY-LAWS
