1987 ANNUAL MEETING

The chapter met in late September 1987 in Juneau. The primary thrust of this year's program was the bootstrapping technique. Prior to the meeting we sponsored the ASA video short course titled "An Introduction to Bootstrapping" by Drs. Bradley Efron and Robert Tibsharani. The short course was held in conjunction with the University of Alaska-Southeast's Juneau Center for Fisheries and Ocean Sciences.

The 1987 annual business meeting of the Alaska Chapter of the American Statistical Association was held during the afternoon of 30 September, the following new officers were elected:

The membership at the meeting voted to approve changes to the Chapter constitution which would alter the terms of office and method of election for the Chapter offices. The terms of office were changed so that the current Vice President will become the President in their second year of service and the President will become an Executive Board Member. The Secretary/Treasurer will hold office for two years. The term of office for the additional Board Member remained the same. This schedule will begin with the 1987 elected officers.

Several additional issues were discussed at the business meeting. Alan Johnson summarized the 1987 National ASA meeting which he attended in August. ASA is considering restructuring JASA and merging American Statistician and Amstat News.

National ASA is also very interested in our responses to their continuing educational videos and is distributing surveys. Barbara Bailar, National ASA president was scheduled to be in Anchorage the week of 4 November and would like to meet with interested members. She works for the Census Bureau and would be on business and would be willing to discuss her current work involvement with the 1990 census (*Editor's note Ms. Bailar had to cancel her visit*). The "1987 Directory of Alaskan Statisticians" produced from surveying our chapter membership was available to those attending the meeting. A vote was passed to send Don Marx, editor, a letter in appreciation for his work. The membership also passed an advisory vote (to the Vice President, as program coordinator) that the 1988 annual meeting be held in Anchorage in late September or early October.

Discussion regarding speaker(s) and short courses for the 1988 meeting resulted in an advisory vote that a speaker and perhaps a short course were desired for next year. The following topics and speakers were mentioned and prioritized (with highest priority first):

Several all around speakers who might be interested in visiting Alaska were recommended, Bruce Linsay of Pennsylvania State University, teaches in the Statistics department with experience in fisheries and wildlife management (recommended by

Terry Quinn) and Ken Wachter, a demographer (recommended by Bob Fagen). It was also decided to rent the ASA continuing education videotape "Data Analysis of Multivariate Observations" for viewing in Anchorage, Juneau, and Fairbanks this spring.

Our guest speaker at our annual meeting was Dr. Stephen Buckland (previously of the University of Aberdeen, Scotland, and the Inter-American Tropical Tuna Commission, La Jolla, California). Dr. Buckland presented two papers titled: "Bootstrap standard errors and confidence intervals" and "Applications of the bootstrap to quantify precision in the field of animal abundance estimation".

Additional papers presented by Chapter members included the following talks: Dan Reed discussed "Ratio estimation with small sample sizes"; Bob Conrad presented a paper titled "Bootstrap estimation of standard errors for angler catch rate data"; Alan Johnson discussed "Bootstrapped classification matrix for discriminant analysis and confidence intervals through percentile methods and density estimation techniques"; Earl Becker talked about an "Overview of mark-recapture estimation of Brown Bear populations"; Linda Brannian presented an "Overview of an application of mark-recapture in western Alaska fisheries"; Hal Geiger made "Some spontaneous comments on the application of bootstrap to an Alaska coded wire tag problem"; Mike Thomas's paper was on an "Overview of hunter economic surveys"; and Steve Thompson talked about "Adaptive sampling in fisheries and wildlife". All talks were well attended by Chapter members and students from the University. - Allen Bingham and Linda Brannian
