Abstract: What kind of person studies statistics, and then never does any data analysis, teaching, or research? One such kind is

a statistical software developer. The speakers will give a glimpse of life in statistical software development, using the MATLAB Statistics Toolbox and other software as examples. Some of the daily challenges include designing software to give accurate results and deal gracefully with extreme cases, understanding requests for unfamiliar statistical methods and tracking down ways to provide them. Other challenges include turning academic or textbook algorithm descriptions into software that works in real situations, and trying to design and explain complicated methods so they are usable by a wide audience. These and other challenges must be met simultaneously with meeting imposed deadlines and the "bottom line". The speakers will also address what drives the daily decisions that they

need to make.
