Dear IM Division Members,

We look forward to seeing you at the first Hybrid #AOM 2022 Annual Meeting! The meeting runs from 4 to 9 August. The Virtual sessions of the program will take place on the virtual platform at: https://22.aom.org/, with the On Demand sessions running on August 4 and the Virtual Live sessions throughout the conference. The Hybrid and In-person sessions will be in Seattle 5-9 August. To ensure a safe in-person conference experience, a COVID-19 Health & Safety Policy will be in place during the meeting. This year, the PDW Chair, Nandini Lahiri, and I have worked together to offer an "almost back to normal" program with the PDW sessions scheduled on Friday, August 5 and Saturday, August 6 and the Main Program sessions scheduled on Monday, August 8 and Tuesday, August 9. We have also taken stock of the past two years and scheduled a Consortia day on Sunday, August 7.

In addition to the terrific PDW sessions (which Nandini Lahiri describes elsewhere in the newsletter), we have 78 IM Division paper sessions and 22 IM-sponsored Symposia, many of which are in collaboration with other divisions, sharing a broad range of insights. This year, the vast majority of program sessions will be held In person, and some of these will be Hybrid streamed live. The remaining sessions will take place Virtual Live and On Demand. A selected number of In-person sessions will also be recorded for later viewing if you cannot make the original session time.

The traditional IM Division Thought Leadership Café will take place Hybrid on Monday, 7:45 am – 8:45 am (PDT). Join us and have an informal conversation with our thought leaders, Klaus Meyer (Ivey Business School) and Rosalie Tung (Simon Fraser University), who will share their views on the evolution of the IM field and related opportunities and challenges for research. I trust the conversations will be lively, wide-ranging, and thought-provoking. Aligned with the Division's mission and its focus on the impact of cross-border forces on firm strategy, organization and management, this year's program also includes an IM Division Though Leadership Café' on the Ukrainian crisis. This will take place Virtual Live on Sunday, 2:30 pm – 4:00 pm (PDT) and host a conversation, moderated by Alexander Settles (U. of Florida), on the impact of the current crisis on the geopolitical framework and the international business environment.

The finalists for the D'Amore-McKim School of Business, Northeastern University Best Dissertation Awards will present their doctoral research on Monday from 2:15 pm – 3:45 pm (PDT). These young scholars will provide cutting-edge insights on a range of topics in our field. This will be immediately followed by the IM Division Eminent Scholar Award presentation by 2022 Award Recipient Don Lessard (MIT) from 4:00 pm – 5:30 pm (PDT) and then the IM Division Business Meeting from 5:45 pm – 7:15 pm (PDT). At the Business Meeting, the IM Division Best Paper Awards will be announced, and the IM Division Professional Achievement Awards presented: Stephanie Lenway, University of St. Thomas Minnesota (AmorePacific Outstanding Educator Award), Liang Chen, University of Melbourne (FIU Business Emerging Scholar Award), and Lorraine Eden, Texas A&M University (Outstanding Service to the Global Community Award). All these sessions will be Hybrid streamed live to ensure wide participation of our members.



## **Welcome our New Executive Committee Member**

Klaus Meyer is joining the IM Division Executive Committee and will begin his five-year term on the division's leadership team, serving as PDW Program Chair for the 2023 AOM Annual Meeting in Boston, Massachusetts.

Klaus Meyer (www.klausmeyer.co.uk) is a Professor of International Business and William G. Davis Chair in International Trade at Ivey Business School, London, Ontario, Canada. Until 2017, he spend six years at China Europe International Business School, where he was the Philips Chair and Professor of Strategy and International Business.



Previously he has also been faculty member at Copenhagen Business School, the University of Bath, England and University of Reading, England, and held visiting appointments at the Hong Kong University of Science and Technology and at National Cheng-chi University, Taipei.

He is a leading scholar in international business, focusing on the strategies and operations of multinational enterprises in and from emerging economies. His research emphasizes the role of context on many aspects of management, and the contextual boundaries of theories of management. His theoretical contributions apply and advance in particular institution-based theories.

He is a Fellow of the Academy of International Business (AIB), and in 2015 he received the Decade award of the Journal of International Business Studies (JIBS). He served as Vice President of the AIB, and in this function chaired the 2014 AIB conference in Vancouver. From 2016 to 2022, he serves as an area editor of JIBS. Other editorial roles include Book Review editor for JIBS, Deputy Editor-in-Chief of Management and Organisation Review, and area editor of Asia Pacific Journal of Management. He has edited special issues for, among other, JMS, GSJ and JIBS.
