## IMD Focus for 2010-2011

Dear IMD members,

We had another successful year in 2010. The International Management Division (IMD) continues its growth with a membership of almost 3,000 scholars from all around the world. The Division owes greatly to many people for the rich and innovative meeting in Montreal. We were able to organize various innovative activities due to the invaluable contributions from many volunteers and sponsors. I am certain we will be able to repeat, and possibly exceed, 2010's success in 2011. The IMD continues to evolve as a platform that enriches its members' knowledge and skills in research, teaching, and practice in international management. Let me share a few issues and priorities for the Division in 2011.

The Executive Committee (EC) will further explore the idea of expanding our Division's activities beyond the Annual Meeting. So far, the AOM Annual Meeting has been the only venue to bring our members together and share their views and expertise. The final report should be available for the community by this summer. Although the survey is over, we are still open for suggestions. Please feel free to write to any EC member and share your views.

AOM 2011's theme, *West Meets East*, is very much in line with what the IMD focuses on. We should be able to showcase sessions and activities at the Annual Meeting that address the theme in interesting and innovative ways. Internationalization is also part of the AOM's new mission, where we could play an important role. We look forward to your input to have more aligned and creative programs at the Annual Meeting and to help the Academy become a truly international community.

We are grateful to Samsung for its sponsorship of our Division's Best Paper Award and Best Paper in Strategy/IB Theory Award during the last three years. Our collaboration with Booz & Co. continues with the IMD Booz & Co. Eminent Scholar Award. All awards will continue next year with some changes in sponsorship. SKOLKOVO Moscow School of Management will be the new sponsor for the Division's Best Paper Award for the next five years. 

Over a century ago in *The Ballad of East and West*, Rudyard Kipling addressed difficulties of bridging great divides. Times have changed, but barriers still exist. AOM's conference theme of "West meets East" symbolizes among other things, a need to transcend rigid conceptions of borders, regions, and mindsets. The reality of the increasing interconnectedness of our world is driving change in business, management, research, leadership, and relationships among countries. However, physical distance and localization still matter, as do differences in linguistics, cultures, regulations, and consumer preferences. Transcending borders and barriers is especially relevant to the International Management Division (IMD), and we encourage submission of papers and symposia exploring change in, and consequences of, how people and organizations approach global interconnectedness. The theme of "West meets East" also symbolizes a shift in the economic balance of power, thus we look for submissions that investigate how this shift changes the research agenda, the factors we must attend to, and how mindsets need to adapt.

IMD is dedicated to research and teaching pertaining to theory and practice of cross-border or cross-cultural management. Major topics include international competitiveness of firms, industries, and nations; cross-border management, including multi-country, multi-unit strategy formulation and implementation; evolving organizational forms and management practices in cross-border business; cross-border impact of cultural, social, economic, political, and institutional forces on strategies, organizational forms, and management practices; and comparative studies involving two or more countries. With this in mind, we seek innovative and provocative submissions that bring together an international community of scholars working to enhancing our understanding of business, management, research, and teaching in international contexts.

**Submissions:** AOM's online submission system (<http://submissions.aonline.org/2011>) is **open between Nov 2, 2010 and Jan 11, 2011 (5:00 p.m. EST)**. IMD invites submission of innovative empirical or conceptual papers, symposia, and panels that focus on international management research or teaching. We encourage integration of academic, corporate, governmental, and non-governmental perspectives to better understand phenomena. We also seek work investigating how global issues affect multiple stakeholders and the balance of stakeholder interests. Please note the following changes to the types of submissions: The Visual Village and Interactive paper sessions have been discontinued. The Scholarly Program now consists of six different types of sessions: (1) Divisional Presentation Paper sessions; (2) Divisional Roundtable Paper sessions; (3) Cross-Divisional Paper sessions; (4) Discussion Paper sessions; (5) Divisional and Co-sponsored Symposium sessions; and (6) Caucus sessions.

# IMD Barry M. Richman Best Dissertation Award Competition 2011

The Barry M. Richman Award is presented to the best dissertation submitted to the International Management Division. A plaque and cash prize of \$1000 is awarded to the author of the winning dissertation.

### Eligibility Criteria

- The award competition is open to all Ph.D. and D.B.A. students who have successfully defended their dissertations during the 2010 calendar year.
- Dissertations submitted to other competitions are eligible.
- All applicants must be members of the IM Division.
- The dissertations must contribute to basic or applied knowledge on topics within the domain statement of the IM Division.

**Domain Statement:** The International Management Division focuses on research in management and organization theory, research, and practice with a cross-border or cross-cultural dimension. Major topics include: the international competitiveness of firms, industries, and nations; the cross-border management of operations, including multi-country, multi-unit strategy formulation and implementation; evolving organizational forms and management practices in cross-border business; the cross-border differential impact of cultural, social, economic, technological, political, and institutional forces on strategies, organizational forms, and management practices; and comparative management studies involving two or more countries.

### Submission Guidelines

- Submit electronically a 10-page, double-spaced abstract, set up with margins of one inch (2.5 cm) on every side and no smaller than 12-point font. This abstract should include a description of the dissertation's objective, theoretical foundations, relation to prior research, methodology, findings, limitations, and contributions to the field of international management. Listings of references are not included within the 10-page limit, but all other text, figures, tables or illustrations are included.
- Submit the abstract in PDF format & make sure that there is no author identification information.
- Submit via E-mail to **IMD Division Chair, Sam Park (SKOLKOVO)** at [spark@skolkovo.org](mailto:spark@skolkovo.org)
- Submission deadline for abstracts is **March 1, 2011**.

### Evaluation Process

- The IM Division Research Committee will conduct the first round of reviews of the abstract submissions and select three to five finalists based on the quality of their abstracts.
- These finalists will be notified via email by April 15, 2011.
- The finalists will then submit their full dissertations for further review and selection.
- The final results of the selection will be announced at the business meeting of the IM Division at the 2011 AOM annual meeting.

### Obligations for Finalists

Being selected as a finalist is an honor. Finalists are required to present their dissertations at a specially designed session during the 2010 AOM Annual Meeting in San Antonio, Texas, USA. Please submit your abstracts **ONLY** if you agree to this requirement, and agree to be present at the division's Business Meeting where the winner is announced.

## Calls for Nominations

### IMD Outstanding Educator Award 2011

The IMD Outstanding Educator Award recognizes continuous excellence and innovation in teaching International management at all levels and in a global context. The winner is awarded a plaque and cash prize of \$500.

#### **Eligibility Criteria**

- Candidates have to be nominated by others; no self-nominations are considered.
- Nominees must have at least 15 years of teaching experience in the area of international management.
- Nominees must be members of the IM Division.

#### **Selection Criteria**

Candidates are evaluated based on the following criteria:

- Demonstrated outstanding teaching capabilities in the area of international management over a long period of time. May have been extensively involved in the training of other outstanding teachers.
- Had an important impact on international management pedagogy through demonstrated expertise or by developing new and different teaching methods that were subsequently widely adopted by others.
- Advanced the development of outstanding scholars and the scholarship of others in the area of international management.
- Made major contributions to the global dissemination of international management knowledge.

#### **Nomination and Evaluation Process**

- Nomination letters should be e-mailed to the **Teaching Committee Chair, Steve Weiss (York U.)** at [sweiss@schulich.yorku.ca](mailto:sweiss@schulich.yorku.ca) with a **subject heading, "IMD Outstanding Educator Award"** by **April 1, 2011**.
- Nomination letters (max. 3 pages) should provide a rationale of how the nominee meets the eligibility and selection criteria above.
- The IMD Teaching Committee will review all nominations and select up to 3 finalists by April 20, 2011.
- Finalists will be asked to provide additional documentation (e.g., letters of support from department heads, colleagues, and former students).
- The Teaching Committee will review the candidates' files and provide its evaluation of the three candidates to the IMD Executive Committee for the final selection.
- The award will be announced and presented to the winner at the business meeting of the IM Division at the 2011 AOM annual meeting.
