## **NEW ORLEANS 2004** D. Eleanor Westney, Program Chair

This August, New Orleans will be a hot spot intellectually as well as physically – the place for the members of the Academy of Management International Management Division to gather. From the official IM Division Welcome at 8:30 a.m. on Monday, August 9, until the last panel finishes at 4:30 p.m. on Wednesday, August 11, Division members will have an array of presentations, panels, symposia, and social events that will keep them happily occupied in the air conditioning of the hotel, until the cooler night air entices them out to enjoy the delights of one of America's most distinctive urban environments.

Each year, the Division celebrates the achievements of members of the IM community. This year, on Monday afternoon, we honor Alan Rugman, the recipient of this year's Eminent Scholar Award. On Tuesday afternoon at 4:10, the finalists for the Barry Richman Dissertation Award present their research. And at the IM Division Business Meeting that follows, we celebrate the winners of other Division awards, including the Best Paper Awards, the Douglas Nigh Award, and awards for the best reviewers. We encourage all members of the Division to attend the Business Meeting, to participate in the celebration of the achievements of our members and in discussions of the Division's activities.

This year, we are sponsoring nine symposia, four of which have been selected as Showcase Symposia. These Showcase Symposia include two that address the theme of this year's meeting, "Creating Actionable Knowledge". One is a panel on "The Coproduction of Knowledge: Voices from Across the Pond," organized by a group of markmlennon@hotmail.co Fellows from the Advanced Institute of Management Research in the United Kingdom, focusing on the production of actionable knowledge through cooperation between scholars and practitioners. The other is "Driving Global Sustainability: Toward an Integrative Policy Mix for Corporate En-

vironmental Policy." Both of these symposia are on Tuesday.

This year the Academy has adopted an format suggested and tested last year by the IM Division Program Chair, Schon Beechler: Interactive Paper Sessions, in which the formal presentations are limited in favor of discussions and debates among the authors and with the audience. Each division was asked to nominate 10% of its submitted papers for Interactive Sessions (this meant 27 of the IM Division's papers), and the Academy then organized those papers into sessions. We urge IM Division members to look out for these sessions in the Program, and to participate in making them a success.

This year's program was built on the large number of excellent papers that were submitted to the Division. Two hundred and seventy-four papers were submitted to the Division this year, of which our 248 reviewers accepted 155. Each year, we draw heavily on the professional spirit of the IM community to perform this crucially important and demanding task of review and evaluation. This year, over 40% of our reviewers are based outside the United States, reflecting the growing global reach of our Division (two years ago, that percentage was 30%).

Last but not least, the Division offers a social event on both Monday and Tuesday. On Monday, the BAH Eminent Scholar reception at 7:00 p.m. is sponsored by Booz Allen Hamilton. And on Tuesday, following the Business Meeting, the justly famous IM Division Social offers an evening of food, fellowship, and music that will again be the envy of other divisions. We look forward to seeing you there.

This year the IM Division is sponsoring or co-sponsoring 25 PDWs at the Academy, of which IM is the lead sponsor for 14 sessions. Please visit the Academy website to get all the details on specific sessions, but I will point out some highlights here.

The program includes a number of innovations from the recent past that have proven quite successful. For instance, we will once again have an "IM adventure" on Friday--this time involving a swamp tour and a plantation visit. We will also have that same evening a session to explain the IM Division's Program in New Orleans, followed by dinner with representatives of the IM Executive Committee. Also on Friday, we will have a special panel session featuring academics, practitioners, and policymakers on the implications of CAFTA (Central American Free-Trade Agreement) for manag-

The program on Saturday includes the two events that are at the heart of the PDW activities, i.e. the Doctoral Consortium and the Junior Faculty Consortium, each running the full day. In addition, we ticipate in moving the field forward. have the first of two PDW sessions being organized with the BPS Division--this one titled "Conversations on International Strategy and Management." The aim of these sessions is to strengthen dialogue between the IM and BPS membership and to build more on each other's work. Saturday also features two sessions on another thrust of the entire program, namely to serve the specific needs

Finally, Saturday concludes with the PDW reception, which we hope will sions and others who seeking to network with IM members.

Sunday features several interesting sessions, including a panel on how to teach executives more effectively, featuring experts on this subject from a number of schools. Another innovative session explores the question of why some IM research has had lasting impact on the field. This session is in fond memory of Sumantra Ghoshal, who was to participate in it, along with Professors Yair Aharoni and Jean-Erik Vahlne. Speaking in Sumantra's place, about his work, will be Professor Chris Bartlett and Eleanor Westney. I hope this session will help us honor Sumantra's contributions to our field and think about an issue that so concerned him, i.e. how to do research that has lasting impact on theory and practice of IM.

Sunday also features important sessions on research methods, on how non-US scholars can be more successful in publishing in leading journals, and a second joint session with the BPS division entitled "Conversations on Corporate Strategy." Sprinkled through Saturday and Sunday are also other popular topics on how to conduct IM research effectively and managerial issues in operating across cultures.

I hope many of you will take advantage of the creative sessions put together by good school year. One trend that will help our financial future is our membership growth. As of April 21<sup>st</sup> we have IM members for the 2004 PDW and par-

## April 2004—IMD Treasurer's Report—Debbie Francis

Greetings! I hope you all have had a good school year. One trend that will help our financial future is our membership growth. As of April 21<sup>st</sup> we have 2294 members, which is an increase of 3.5% or 78 members (1382 U.S., 912 non-U.S.). For forecasting purposes, I still use a conservative number.

The low interest rates continue to take a toll on the income-generating capability of the endowment accounts, thus requiring us to rely heavily on the operating account to fund awards at the levels we desire. The interest rate for 2003 was 2.35%, which is not bad these days. I am using 2.5% for planning purposes since a rate increase appears imminent Remember, the division can no longer transfer funds from the operating account to the endowment account, but an individual can send a donation in any amount at any time. The donation would be tax deductible.

The good news is that we have received confirmation that Elsevier will sponsor the Best Paper Award through 2006 and that IMD will sponsor the PDW social through 2006. Even though I budget conservatively, the out-year projections always appear grim (deficit spending). The decrease in the award budget is due to more funding from the endowments. The increase in 2006 "other" budget is due to the 5-year report. As you can see we still have challenges ahead, but appear to be holding our own.
