Time flies—don't wait until the last minute to plan your recertification!

If you're recertifying through Infection Prevention Units (IPUs), your portfolio must be submitted by **October 31, 2025**. Remember—chapter activities count toward IPUs, so now's a great time to make sure you're logging everything.

For CIC® holders recertifying through the internet-based exam, you must purchase the exam by November 30, 2025 and pass it by December 31, 2025, at 11:59 PM GMT (6:59 PM EST).
