QUESTIONS FOR THE GROUP

- Ultrasound gel usage 28 day discard date
 - o Some facilities only have single use gel available, and bottles are available in the high use areas
 - o Some facilities only have single use gel packets
- How are other hospitals complying with HCID standard for TJC?
 - o Educational modules for frontline workers for identify, isolate, inform, signage in multiple languages, etc
 - o Portable anterooms for isolation rooms that do not have an anteroom
 - o Dedicate a section of the ED for a HCID patient
- Do facilities have a central line/CLABSI nurse?
 - o Some facilities it is handled by VAT.
 - o Other facilities have a dedicated central line nurse
 - o One facility has an HAI champion for the ICU/CVICU/CSU and for the PCU/NT
- Do other facilities have a "safety zone" where HCP can walk into a room, not touch anything, and walk out without performing HH?
 - o KU does, you can stay in the safe zone without donning PPE or performing hand hygiene.
 - Other hospitals do not.
