QUESTIONS FOR THE GROUP

- How do you combat education fatigue in the hospital?
 - o Leadership could step in to help people listen if IPAC does not have authority
 - Keep track of who your champions are in the population and how to work with staff
 - Reinforce people doing the right thing so people can start to recognize what they should be doing and changing their own practices (candy, stickers, etc)
 - Reinforce why it's important with data and show why it's important
- Discussion on Artificial Nails What is your policy on artificial nails? Do you restrict gel nails? Is it restricted to only certain employees?
 - No artificial nails for all patient care staff
 - Nursing leadership requested a deep dive on requirement at one facility for NO nail polish whatsoever,
 found from data that normal nail polish is fine, but no gel, no dip, no acrylic
 - o Data has to do with burn unit, NICU, bone marrow transplant, was expanded to all clinical areas
 - Are we doing this because it's a policy, or are we doing this because we're supposed to do it?
 - o Our job to educate, not our job to police
 - o If it's in the hand hygiene policy, then it could be looked at as IPAC's responsibility to enforce

INFORMATIONAL REPORTS

- KS Public Health Liaison
 - Uptick in weekly percentage of emergency room visits for acute respiratory illness (22.0%)
 - Visits for Respiratory illnesses also on the rise
 - Data is updated every Wednesday
 - o COVID-19 numbers are down, but flu numbers are up
 - KS-HAN Accelerated subtyping of Influenza A in hospitalized patients notify Epi hotline if you suspect nonseasonal influenza in a patient for help with identifying H5N1 if Flu A cannot be subtyped
 - Negative pressure room and airborne precautions required for novel influenza until we receive more information on the disease in humans, disease more virulent and can have more dire outcomes. Same precautions taken during H1N1 pandemic
 - Tuberculosis Cases in Kansas City, KS All cases have been addressed, they've either been treated or are completing treatment (active and latent cases)
 - Marburg in Tanzania, Ebola (Sudan virus) in Uganda, Mpox in two travelers returning from area where
 Clade I outbreaks occurring
- KCMO Public Health Liaison
 - o Influenza cases also up on KCMO side, more flu A than flu B, very active flu season

- o Follow quidance from CDC HAN for subtyping of Flu A specimens
- o 3rd week of increase with reported COVID-19 cases, but less reported cases as compared to this time last year, only one COVID-19 related death so far this year
- o COVID-19 Wastewater level in Missouri High, lower than regional trend but higher than national
- More Flu than COVID-19 reported
- o 2 measles cases, one in Texas and one in Atlanta, Georgia area, both among unvaccinated individuals
- Legislative Representative
 - o Various Missouri and Kansas bills pending, please see slide deck for reference
 - Executive orders they are not changing the laws, some of them can go through without Congress approving, but others need Congress's approval
 - o WHO withdrawal will happen within 12 months, want to stop financial contributions to WHO
 - Pulling back bills that were put in place during COVID for Global Health Security
 - o Review and changes to USAID 90 day shut down, then Congress will decide what next steps will be
 - USAID provides medical treatments, vaccinations to high-risk areas, prevents polio from spreading
 - Temporary cessation of health communication from CDC, NIH, FDA some communication has gone back out, but they have to go through president-appointed designee before being released
