Educational Presentation	Ebola Roundtable Discussion: Jessica Silvaggio and the Los Angeles County Department of Public Health Health Officer, Chief of the Acute Communicable Disease Control Program, Chief and staff of the Healthcare Outreach Unit	Jessica Silvaggio presented on her deployment to CDC to support the Ebola response. Some of her key points included: Data was gathered and maintained for each traveler traveling from one of the four Ebola affected countries (EAC) to the United States Travelers first entered the US through one of the five designated airports Travelers were screened by US Department of Homeland Security, Customs and Border Protection Depending on the exposure assessment in the EAC, approximately 5% of travelers since October 2014 went through tertiary screening conducted by CDC CDC notified states and provided data to states on each traveler who would spend 21 days in the respective state CDC notified states using Epi-X notifications CDPH informs Los Angeles County DPH of travelers who will stay in LAC for 21 days To date, LAC has monitored 63 travelers (89% active monitoring)

	 95% of travelers were low risk, 5% were some risk 11 hospitals indicated they would be willing to receive a possible Ebola patient (survey response rate: 50%) LAC Preparedness activities completed with hospitals included emergency department visits and or walk throughs (45), Ebola Virus Disease drills (29), and Ebola Virus Disease policy and procedure review (34) The presentation was followed by a roundtable discussion among LAC DPH and GLA APIC members.
